RESOLUTION AUTHORIZING THE MAYOR TO SIGN A REVISED INCENTIVE PROPOSAL FROM NEW YORK STATE EMPIRE STATE DEVELOPMENT IN CONNECTION WITH THE NORTH UNION COMPLETE STREET TRANSFORMATION PROJECT

WHEREAS, the City of Olean was awarded \$1,000,000 in grant funds from New York State Empire State Development (ESD) in connection with an application submitted through the Consolidated Funding Application Process for the North Union Street Properties Project, and

WHEREAS, ESD has offered a financial incentive package to the City to assist with comprehensive downtown redevelopment efforts, and

WHEREAS, the original Incentive Proposal from the ESD has been revised to redistribute a portion of funding originally allocated for the Manufacturers Hanover building to the North Union Street (NUS) Reconstruction project, and

WHEREAS, the portion of funding redistributed to the North Union Street Reconstruction Project is \$600,000, based on additional project expenditures of approximately \$4,962,000 in street and streetscape reconstruction (aggregate total expenditures of \$5,182,000),

Now, Therefore, Be It Resolved, that the Common Council authorizes the Mayor to sign a revised Incentive Proposal from New York State Empire State Development in connection with the North Union Complete Street Transformation Project.

RESOLUTION AUTHORIZING THE MAYOR TO SIGN AN EASEMENT BETWEEN THE CITY OF OLEAN AND THE OLEAN SCHOOL DISTRICT FOR THE PURPOSE OF AN AERIAL WALKWAY CONNECTING THE INTERMEDIATE MIDDLE SCHOOL TO THE HIGH SCHOOL

WHEREAS, the City of Olean is the owner of a public right-of-way known as "Reed Street" in the City of Olean, New York, and

WHEREAS, the Olean School District is the owner of an aerial walkway connection their Intermediate Middle School to their High School which is suspended over Reed Street between North Third and North Fourth Streets in the City of Olean, New York, and

WHEREAS, the aerial space which is the subject of the easement is not currently being used by the City for a municipal purpose,

Now, Therefore, Be It Resolved, that the Common Council authorizes and directs the Mayor to sign an easement between the City of Olean and Olean School District.

RESOLVED, there will be no fee to the Olean School District for this easement.

RESOLVED, that the Olean School District agrees that the easement shall not be transferrable or assignable without the written consent of the City.

RESOLVED, that the City will grant the Olean School District a permanent easement for the aerial space above Reed Street between North Third and North Fourth Street in the City of Olean, New York.
