Because my attitude and behavior are critical to the success of California Dreamin² 2015, I agree to abide by the following:

1. I understand that as a participant in the Camporee, I am representing the Girl Scouts or Girl Guide movement, my community, and my country and I will do my best to bring credit to all by upholding the Girl Scout Promise and Law.
2. I will do my best to have a positive and cooperative attitude, to follow the trip leaders' and event organizers' instructions, and to be on time for busses. I will be a team player, be sensitive to the needs of others, fulfill my assigned duties and responsibilities in a timely manner, and abide by the rules and standards set by the Girl Scouts of the USA and by my group without complaint.,
3. I will keep myself healthy by staying well-hydrated, eating a proper diet, getting enough rest, and dressing properly; and will not knowingly jeopardize the well-being of myself or others.
4. I will follow all existing and "suddenly created" safety rules, use the Buddy System at all times, and refrain from inappropriate liaisons. Separating myself from the group without permission of the responsible leaders may result in expulsion from the trip.
5. I understand that the use of obscene language, alcohol, illegal or unauthorized drugs, or tobacco products will not be tolerated, and that usage during the trip will result in expulsion from the Camporee.
6. I will be responsible for my belongings and will not hold my trip leaders, Camporee volunteers, Girl Scouts of Northern California, or Girl Scouts of the USA responsible for their loss or damage.
7. I understand that I will be living and interacting with people from different parts of the country and world, from different cultures, and from different time zones. I will do my best to respect differences and adapt my behavior as appropriate.
8. I understand that the terms of this contract apply to me even if I have reached the age of 18.
9. I understand that failure to abide by the terms of this agreement can result in my being sent home immediately from the trip at my parent's arrangement and expense.
10. Any posts or interactions I engage in online or on social media during CD2 will be respectful and in line with the Girl Scout Promise and Law and all other expectations laid out here. This expectation applies to interactions with anyone I meet at CD2, even after the conclusion of the event. I will ask permission to post photos of other CD2 participants or mention them in posts prior to doing so. Finally, I understand that I should have my parent's permission to be online or on social media.
