INFORMATION YOU NEED TO KNOW

Eligibility

DEADLINE TO APPLY IS TUESDAY, MAY 15, 2012

- You must complete <u>BOTH</u> **2011-2012** and **2012-2013** Free Application for Federal Student Aid (FAFSA) applications at <u>www.fafsa.gov</u>
- **SAP** If you do not meet the Standards of Academic Progress (SAP), your summer Financial Aid will **NOT** be processed until a SAP appeal has been approved. (*approval is not guaranteed*)
- Receiving a Direct Federal Unsubsidized Stafford loan for \$2000, will reduce the amount of aid you will qualify for during the regular academic year.
- Summer Pell grant is <u>NO</u> longer available. However, if you started the academic year in January and you are not a transfer student, you *may* qualify for a Pell grant. Please see your Financial Aid advisor for more information.
- In most cases, to be eligible for summer school aid, you must be enrolled for at least six credit hours (half-time). If you take three hours in one session (Summer A or Summer B) and three hours in another session, you will not receive funds until you start your second summer session.
- You are not eligible to receive financial aid if you are not enrolled in a degree-seeking program.

Aid Available for summer:

- 1. Federal Direct UNSUBSIDIZED Stafford Loans
 - The MAXIMUM amount awarded of unsubsidized Stafford loan is \$2,000.
- 2. Federal Pell Grant

You *may* be eligible for a Pell Grant for the Summer Session if you have remaining eligibility.

- 3. Parent Plus Loan
 - Parents of Dependent students **may** be eligible for a summer PLUS Loan.
 - To apply for a Parent PLUS loan go to <u>www.studentloans.gov</u>, sign in and *Complete PLUS application*. If the Parent is *approved*, the Parent must complete the Parent PLUS Master Promissory Note (MPN) at <u>www.studentloans.gov</u>.
- 4. <u>Private Alternative Student Loan</u> for additional assistance, students or parents can apply directly with a private lender. Suggested lenders are listed below:
