a My Bridal Stuff production

My Bridal Stuff (Producer) and Exhibitor _____ agree as follows: **Service.** Producer is not responsible for notifying the exhibitor of other participating exhibitors within the same category. Producer agrees to stage a bridal show on the following dates/locations: the Catta Verdera Country Club on Sunday, September 21, 2014 from 12:00pm to 4:00pm. The following terms and conditions apply to this bridal show. Determination of show participated is list according to page one of Luxury Wedding Shows - Exhibitor Booth Registration Form.

Requested booth locations are not guaranteed. Exhibitor agrees that his booth is not transferable without approval. Producer may use his best judgment in promoting and staging this event. Producer may, at his sole discretion, determine if any display or conduct in Exhibitor's booth is offensive to Attendees. If, upon notice to correct said display or conduct, Exhibitor does not immediately correct said display or conduct, Producer may eject Exhibitor from the show, with no refund of any payments. If Exhibitor has more than the provided number of tables in Exhibitor's booth, Exhibitor agrees to pay the decorating company for them, unless they belong to Exhibitor. Exhibitor agrees not to use other exhibitors' tables without written authorization from Producer. Event program listings will not be provided for exhibitors signing up within 14 days before a show. Producer may for any reason change the date, times, and place of the show by giving Exhibitor ten days notice before the show. Producer may change the floor plan or booth assignments without notice. Exhibitors releases Producer of any liability for damage to or theft of any of Exhibitor's personal effects, display, product, or materials, even if moved by Producer's personnel or contractors. Business listing in event program uses Company Name as shown on the Exhibitor Booth Contract. Producer may shorten name to fit. Producer does not guarantee an exclusive to any exhibitor for any product, service, or category, unless provided in writing. All food and beverage items and sampling sizes must be approved in writing by the Producer no later than 30 days prior to the show and pay applicable County Fee.. Cooking demonstrations are not allowed. Exhibitor empties own booth trash. Exhibitor agrees not to distribute at the show any literature, business cards, or other information for the benefit of any third party. If Exhibitor distributes any literature, business cards, or other information for any other party, or displays photographs bearing the name or logo of any non-exhibiting photographer, or displays the name or logo of a non-exhibitor without prior written permission of Producer, Producer may remove Exhibitor immediately from show and receive damages from Exhibitor in the amount of \$500. Producer may confiscate the names from Exhibitor's drawing, and Exhibitor does not receive the list of brides. Booth sharing between different categories or businesses is NOT allowed. **Electricity is optional and NOT included. Submit request for Electricity on Exhibitor Booth Contract. Electricity outlet requests and fees must be handled a minimum of 14 days before the show. Day of the show requests for electricity are subject to a \$100 fee due onsite, if available.**

Set-Up, Parking, & Removal. Set-up times for exhibitors are 9:00 am to 11:30 am. Additional set up time may be allowed for Sponsored Exhibitors with prior approval from the Producer. If Exhibitor's assigned booth is empty at 11:30 am on the date of the show, Exhibitor forfeits the booth and any moneys paid. Exhibitor agrees to not begin removing his exhibit until the advertised closing time 4:00pm. If so, Exhibitor agrees to pay a \$250 fine, and not receive a list of brides. Exhibitor agrees to be completely removed by 6:00 pm on September 21, 2014. Exhibitor agrees to remove all the trash from his booth at the end of the show or to pay a \$100.00 cleaning fee. Exhibitor agrees to follow all Fire Marshall and the Catta Verdera rules. Exhibitor uses Producer personnel and equipment at his own risk. Catta Verdera Country Club is located at 1111 Catta Verdera Dr, Lincoln, CA 95648.

_____ (initial here) At least one exhibitor/staff/company representative must arrive to claim booth space no later than 11:00 am. Teardown/Packing up begins at 4:01 p.m. Teardown before 4:01 pm is not allowed. **IMPORTANT:** Exhibitors arriving after 11:00 am or tearing down before 4:01 will be charged a \$250 Show Fee using the credit card on file within 2 days after the show and will not receive the brides list.

Terms. A deposit is required to reserve exhibitor space. Space needs to be paid in full by July 15, 2014 to participate in the Luxury Wedding Show at the Catta Verdera Country Club on September 21, 2014. If Exhibitor's checks are not received at Producer's office by those dates, Exhibitor authorizes Producer to use Exhibitor's credit card or debit card to make those payments. If Exhibitor's credit card provided declines at any time, Exhibitor authorizes Producer to use any other credit card previously or subsequently provided by Exhibitor. If an Exhibitor payment declines on the scheduled date, Producer may run that payment at any later date. This Agreement is non-cancelable. **There is no cancellation policy. Payments are not refundable.**

If payments are not made as shown in the Exhibitor Booth Contract, Exhibitor forfeits his booth location and agrees to accept any other same size booth assigned by Producer. If payments are not made as shown in the Exhibitor Booth Contract, all remaining payments are accelerated and due in full immediately. If collection is necessary, Exhibitor agrees to pay Producer's reasonable collection costs, including court costs and attorney's fees. If a payment is late, or if Exhibitor's credit card declines on the date it is to run, Exhibitor agrees to pay a \$35.00 Late Fee (First Occurrence). If payments are not made on time two or more times, the total cost of both show shown in Exhibitor Booth Contract is immediately due in full (Second Occurrence). Exhibitor forfeits his booth and any monies paid if payment in full is not received within ten days of the original due date.

Liability. Producer's liability is limited to refund of actual money paid by Exhibitor. Exhibitor is responsible for any liability arising out of his participation in the bridal show, including product liability, accident, or injury. Exhibitor agrees to work from within his booth and not step into the aisles. If Exhibitor does not stay within the boundaries of his booth, Producer may remove Exhibitor immediately from show, Exhibitor forfeits any money paid, and Exhibitor does not receive a list of brides, and names are confiscated from Exhibitor's drawing box.

Entire Agreement. Payments are refundable if and only if the bridal show is canceled, unless Producer is prevented from doing the bridal show by an act of God, flood, fire, strikes, or other cause beyond the reasonable control of Producer, in which case Producer may retain any payments and reschedule the time & place of the show. This written Agreement is non-cancelable and represents all understandings between Producer and Exhibitor. No oral representations are binding, and all changes to this Agreement must be made in writing and approved by both parties. Exhibitor agrees to pay on time all payments due under this Agreement, even if Exhibitor does not physically use his booth or is unable to exhibit.

Exhibitor/Sponsor agrees to release, discharge and acquit, and to defend, indemnify and hold harmless, K&W Humble Beginning Enterprises, its officers, agents, and employees, staff and members, together with their spouses, heirs, administrators, executors, and assigns and all other persons, entities, associates or otherwise associated with K&W Humble Beginning Enterprises, including sponsors from all other claims or due to the acts of exhibitors, its agents and employees, howsoever designated, and/or loss and/or injury of any nature, demands, causes of action, actions, suits, loss, cost, obligation, or liability or assertions, of damages, together with attorneys fees incurred in responding to the same, by reason of any injury or death to any person or persons, including K&W Humble Beginning Enterprises. Exhibitor/Sponsor assumes all responsibility for loss, theft, or destruction of goods, or personal injuries to him/herself, his/her employees, agents, representatives, or visitors, and will hold harmless K&W Humble Beginning Enterprises, its affiliates and partners from any liability in connection with any or all of the above. Exhibitor/Sponsor is encouraged to insure exhibit property against loss or theft, and those wishing to do so, must do so at his or her own expense. This Agreement is not valid until signed by an officer of My Bridal Stuff.
