Legislative Article by Shirley Clark

January is fast approaching and with it another legislative session! This will be the "short session," lasting 30 days, which is spread out and seems to last forever! Sarah Hurst, our Legislative Agent, and I, as the State Legislative Chair, are currently watching for any pre-filed bills that will be of interest or impact our retirees.

We anticipate several retirement bills to be filed that did not pass in the 2014 session. These bills/issues pertain to pension spiking; quasi-agencies leaving the system; adding legislative, judicial and teachers to the pension oversight board; taking out the provision in the law that does not allow retirees or state employees to serve on the board; and a bill that would require an actuarial experience study of KRS to be conducted every five years rather than every ten years.

The KRS housekeeping bill will be resurrected (and, perhaps be re-written). This was the bill that KPR was instrumental in getting an amendment attached which would allow vacancies of elected member positions on the KRS board to be filled by the elected members of the board. This issue remains very important to our retirees as we continue to push for a more balanced representation of elected vs. appointed members of this board.

On October 21st, the Public Pension Oversight Board met. KPR, as well as other invited organizations, testified. Our President, Paul Guffey, and our Legislative Chair, Shirley Clark, discussed our concerns on bills that may be introduced as well as the importance of

continued full funding to assure stability and solvency of the system. We also expressed concern that at the end of the 2016 biennium, retirees will not have received a COLA for four years and stressed the importance of an adjustment for all retirees.

As we follow the legislative website on the pre-filed bills, you will be kept informed of all the news that pertains to retirees. We will keep you updated once actual bill numbers are assigned. The toll-free number for you to be able to call your legislator when the session begins is 1-800-372-7181. You can also contact them via our KPR website, which provides their email, home addresses and phone numbers. Again, I cannot tell you how important it is for a legislator to be contacted by the person who elects him or her.

As we approach 2015, we are pleased to announce new changes which we feel will promote membership growth and enhance the effectiveness of our organization. Spouses will now have the opportunity for KPR membership, with the first year of membership free in the year which they join. Membership dues thereafter will be \$15 per year, the same amount as any other member. All spousal memberships will be tracked in the KPR database. Please enroll your spouse as a member today. Take advantage of the first year of free membership. You can

modify the current membership application by writing the word "Spouse" near the date on the application. Membership of spouses has been included in the online application. A new membership application is in the design process at the present time.

As a convenience to our members, the Administrative Manager has added the option of allowing members the ability to pay their KPR dues online. Those individuals wanting to use this method of payment are encouraged to go to the KPR web site and click on the dues payment tab at the top, select the option of paying for one year or two years and click submit. You will be directed to the PayPal page where you will have the option of using a PayPal account or your own personal credit card. Members will also still be able to pay their dues by mail after receipt of a dues statement or pay at your local chapter meetings. The dues statements will be mailed on or about December 31, 2014. Those individuals who have already prepaid their dues will not receive a statement.

In 2015, we will again be holding a Membership Contest. Winners will be recognized at the Annual Meeting. This contest will begin January 1, 2015, and end May 31, 2015. The first-place prize of \$50 will go to the individual who recruits the largest number of new members during the contest period, the second-place prize will be \$35, and the third-place prize will be \$15. The chapter which has the largest percentage increase during the contest period will receive \$25. We will also have a random drawing prize of \$25. Every member who has referred a new member has a chance to win. Please get busy - we need members. Our membership number is so important when our Legislative Chair and Lobbyist start their work during the next legislative session. Start your recruiting early - you can make a difference. We need your help - ask your former coworkers, friends, and family members.

Retirement System Update by Larry Totten

Over the past few months, there have been several meetings by KRS, its Committees, and the Public Pension Oversight Board.

The Investment Committee met on August 5th and was provided an overview of activities of the investment staff. The Committee heard presentations regarding investment opportunities and approved the proposals sending them to the full Board for consideration. The Committee approved a proposal from KRS' general investment consultant for an Asset Liability Study, which was last done in 2009. This study provides guidance into which areas KRS should allocate its investments and is required no less than every five years. All five pension funds and all five insurance funds will be included at an approximate cost of \$485,000.

The Audit Committee met on August 7th at which KRS' auditing firm discussed the upcoming FY14 audit. Results will be presented at this Committee's November meeting and the Board's December one. The Committee was given unaudited financial statements for the just-ended fiscal year. Net plan assets for all five pension plans increased by about \$862 million; all insurance trusts increased by about \$630 million. Amidst this good news was the disturbing news that the *KERS Non-Hazardous plan assets decreased by about \$183 million*.

The Retiree Health Care Committee met on September 4th with agenda items dealing with the approval of health insurance rates for 2015. Non-Medicare eligible employees will stay covered under the same plan as that provided to Kentucky state government employees. For retirees eligible for Medicare, the Medicare Advantage plan from Humana will continue for another year. As a result of having actual plan usage (CY2014) in hand, new and expensive drugs becoming available, and lower net federal government reimbursement, Humana was requesting a 15% rate increase. While a significant amount, it was noted that the proposed rate (\$244.25/month) was still notably less than the actual 2012 rate paid (\$300+), the last year that retirees were covered under the self-

insurance plan. The RFP for Medicare eligible retirees' insurance coverage for the 2016 plan year and beyond will be reviewed at the next Committee meeting.

The KRS Human Resources Committee met on September 11th. The Committee approved providing KRS employees with the same increments as those being provided to state employees. The Committee also approved a request to provide tiered monetary incentives to employees, as opposed to the vacation days given to state employees, for evaluations with above-average performance ratings. Both of these were to take effect on September 1.

The Board of Trustees met on September 11th and was attended by Rep. Brent Younts, Co-Chair of the Legislative Public Pension Oversight Board. Bill Thielen, Executive Director, made two personnel announcements: Becky Stephens as Chief Benefits Office and David Peden as Chief Investment Officer. As is the case with each quarterly meeting, there were a number of standard reports given to the Board by various KRS staff. The Board approved the recommendations made by the KRS Human Resources Committee, Audit, Retiree Health Care, and Investment Committees. It was announced that there are two candidates for the elected State Police Retirement System position and the Board approved both applicants. Barring any petitions submitted, eligible voters will choose between Keith Aaron Piercy and Lisa Marie Rudinsky. (Piercy is an active member of SPRS and Rudinsky is retired.) Executive Director Bill Thielen discussed the webinars done by Peden and himself as an attempt to inform the public about the workings of KRS. The Board reviewed the actual-vs-budget performance of KRS for the fiscal year ending June 30. As KRS operations are funded out of the trust funds, FY14 ended \$5.9 million under budget but with several areas recording more spending as a result of litigations. Thielen presented items he believed would be brought up in the 2015 General Session; essentially, the same proposed legislation presented, but not passed, during the 2014 Session. He also announced that the RFP for Communications Services was withdrawn after bids came in, noting the high cost of the proposals. Board Chair Thomas Elliott, along with Peden, announced that KRS would begin website posting of the fees to be paid for investment managers once they are approved by the Investment Committee. It was noted that these may not end up being the actual fees paid, as KRS would continue to negotiate for lower fees, but would be those approved by the Committee at their public meetings.

There have been no recent announcements regarding the Seven County Services litigation. The case brought against KRS by the city of Fort Wright was moved from Kenton to Franklin County Circuit Court but there have not been any recent announcements regarding this case, as well.

The Legislative Public Pension Oversight Board has had three recent meetings. The first, on August 28th, dealt primarily with KRS investments. David Peden, Chief Investment Officer, provided a broad outline of what KRS was doing in terms of investments, why it was doing so, and how well it was doing. The question of disclosure of fees paid to fund managers created the most discussion. The Board next met on September 25th with an agenda concerning legislative proposals expected for the 2015 session of the General Assembly. Since most of the 2014 legislative proposals were not passed, all should be expected to return for this next session. The latest meeting of the Board occurred on October 25th, at which various groups were allowed to make presentations relevant to the Retirement System. Resolving some pension "spiking" issues brought about by SB2 and protecting CERS funding from the problem that exists with the KERS Non-Hazardous were the topics most discussed by the other presenters. This Board will be presenting a report to the General Assembly in December.


