#### 8. REGULAR CALENDAR:

#### a. **MR 13-035:**

CONDUCTED APPEAL HEARING AND MADE DETERMINATION TO GRANT THE APPEAL CHALLENGING THE DISTRICT'S CAPACITY CHARGE REQUIREMENT AND DEMOLITION CREDIT EXPIRATION AT 1318 SEMINARY STREET. A RESOLUTION MAKING A FINDING OF SPECIAL CIRCUMSTANCES TO BE BROUGHT BEFORE THE BOARD FOR CONSIDERATION AND APPROVAL.

Chair Techel called the hearing to order. District Sr. Civil Engineer, Andrew Damron, presented the District's oral argument explaining District staff's reasoning for denying the Appellant's appeal. He gave background information and discussed the District's Code rules on residential connections to the sewer system. Damron referenced District Code Section 5.02.050 states that "Capacity charge credits shall be valid for a period of two years from the date the demolition permit is issued by the District, and shall remain with the parcel from which they were established. The property owner must obtain a City or County building permit within the two-year time frame in order to utilize the capacity charge credits. The value of the credits shall be based on the type of unit and/or fixtures that have been removed from the parcel."

A demolition permit for the property was issued on March 30, 2009. The previous owner's demolition contractor, Harold Smith & Son, signed a District form acknowledging that demolition credits will become void after two years. Per District Code, the demolition credits expired on March 30, 2011. The applicant, Robert Ackley, submitted plans to construct a new residential unit on April 5, 2013. It was noted that during the 4-year period since the demolition permit was issued, this property was not assessed for sewer service charges.

Applicant Robert Ackley presented his position to the Board. Ackley noted that the new residence would not use any more capacity than the previous house on the property. Additionally, Ackley noted that the District's 2-year expiration was inconsistent with other agencies development fees.

Chair Techel closed the appeal hearing and the Board held discussion on the appeal. A motion was made by Director Shinnamon and seconded by Director Mott to grant the appeal and refund the \$7,000 capacity charge less the amount that would have been paid had sewer service charges not been suspended, which was approved by a majority of the Board. Legal Counsel Bakker was directed to draft a resolution making a finding of special circumstances and bring that resolution back to the Board for consideration at the next Board meeting.

Jeff Tucker, Director of Administrative Services/CFO, presented the Strategic Plan with examples on time frames from past Quarterly Reports. The Board held discussion with staff on the objectives in the plan. The Board gave direction to staff to make minor revisions in "Current Trends, Challenges and Opportunities." Staff will add schedules to objectives once they are approved by the Board.

# c. Receive presentation from staff on the proposed FY 2013/14 Operating Budget.

Jeff Tucker, Director of Administrative Services/CFO, gave a presentation to the Board on the proposed Operating Budget for FY 2013/14. Tucker indicated that the cost of salary and benefits went up 4.7%, however services and supplies were

reduced by 6.1%, for a net impact of 0.4% increase over FY 2012/13 operating budget. Debt service increased due to the issuance of new debt in FY 2012/13 to pay for capital projects. Capital expenses doubled in 2013/14 due to the Phase I Recycled Water Project, Influent Pump Station replacement, and MST pipeline project all starting construction next fiscal year.

Tucker presented the Ten-Year Forecast. The forecast is not balanced, with the District showing insufficient resources to cover planned expenditures starting in FY 2016/17. Tucker presented ideas to resolve the deficiency, ideas developed from discussions with the Board's Finance Committee and Long-Range Planning Committee.

Tucker reported that the Ten-Year Capital Improvement Plan will be presented to the Board at the May 15<sup>th</sup> Regular meeting. The combined operating budget and capital improvement plan will be presented to the Board for consideration and adoption on June 5, 2013.
