Camp Fully Involved is an intense, hands-on fire service based camp for young women between the ages of 14 and 20, who are interested in a career in the fire service. Class size will be limited to 24 cadets in order to provide the safest, most interactive hands-on program. Applicants not accepted into the 2015 program will be considered first for the 2016 program. Preference will be given to non-returning cadets. Only COMPLETE applications will be reviewed and accepted. A complete package will include the cadets application, 2 letters of recommendation and a 500 word essay. Selection for the program is random, and no preference is given to applicants who may have fire service experience or affiliation.
