The following described land within your grazing allotment has been identified for the purpose of constructing the (name) solar facility.

As discussed with you previously, if this solar project is approved, the action may require livestock grazing permit cancellations, in whole or in part, on the allotment. According to the BLM grazing regulations 43 CFR 4110.4-2(b) (2005): “When public lands are disposed of or devoted to a public purpose which precludes livestock grazing, the permittees and lessees shall be given 2 years’ prior notification except in cases of emergency (national defense requirements in time of war, national disasters, national emergency needs, etc.) before their grazing permit or grazing lease and grazing preference may be cancelled.” The intent of the 2-year notification is to provide the grazing permittee/lessee time to make any necessary financial, business, or management adjustments should the permit/lease be cancelled, in whole or in part. This letter constitutes official notice that land is being considered for another purpose that could result in a partial or complete reduction in your permitted use.

43 CFR 4110.4-2(b) (2005) provides you an opportunity to waive the 2-year notification period. If you have no objections to the proposed action, the enclosed waiver should be signed and returned to this office. Such a waiver will not prejudice your right to reasonable compensation for, but not to exceed the fair market value of, your interest in authorized permanent range improvements located on these public lands (see 43 C.F.R. 4110.4-2; 4120.3-6).

Within 30 days after the decision on the environmental analysis, you will also receive a grazing decision specifying the extent to which your permitted use is being cancelled. The grazing decision will be subject to protest under 43 CFR 4160.2 and/or appeal under 43 CFR 4.470.
