PUBLIC HEARING FOR THE NAMING OF A PUBLIC FACILITY

A Naming Committee to consider proposals for the naming of the red pedestrian bridge over the East Branch of the Rahway River at the north end of Meadowlands Park was created by adoption of Resolution #226-10 on August 16, 2010. The Naming Committee held a meeting with public notice on October 13, 2010 to obtain input and extended a 30-day period for written public comment on the naming proposal. The naming proposal and 30-day written public comment period was as advertised in the News Record on November 4th and was posted on the Village Website. The 30-day written comment period ended on Saturday, December 4th. The Village Clerk attests no written comments were received on the naming proposal. The naming proposal is now placed on the Board of Trustees agenda for Public Hearing.

THE NAMING COMMITTEE'S RECOMMENDATION IS TO NAME THE REFERENCED BRIDGE "JONATHAN'S BRIDGE," IN MEMORY OF JONATHAN FELSMAN'S SUBSTANTIAL CONTRIBUTIONS TO SOUTH ORANGE'S OPEN SPACE, RECREATION, AND ARTS PROGRAMS AND TO PLACE A PERMANENT MARKER OR PLAQUE UPON OR NEAR THE BRIDGE TO MEMORIALIZE THE NAMING OF THE BRIDGE.
