- In the event full payment is not made to G&JPhotography within six (6) months of the event, we reserve the right to use images for display, publication or other marketing purposes (initials) _____
- The Hold the Date deposit is required at time of contract signing and is nonrefundable after 30 days and will be used towards the package purchase. (initials) _____
