To release a lien on an existing title, please complete this form and send it with the existing title to the Department of Motor Vehicles with the **\$33.00** fee. If this form, TA-VT-08, is received along with an Application For Duplicate Title, TA-VT-04, there is no fee to release the lien, only a **\$33.00** fee to produce the corrected title.

- ➔ A meter reading is required if the vehicle is titleable (15 years old or newer based on calendar year). If vehicle is **not** so equipped, a statement to that effect is required. The statement **must** describe vehicle by make, model, year and VIN (serial number). All readings must be in whole numbers categorized as miles, kilometers or clock hours or application will be returned. **Please enter the appropriate information below and check the appropriate box.**
