SafetyBeltSafe U.S.A. is accepting applications for the Standardized Child Passenger Safety Training Course for prospective Certified Child Passenger Safety Technicians. If you are already certified, please share this information with your colleagues.

We have scheduled a class at the Training Center of Pomona Police Department, April 2, 3, and 4. The Training Center is located at 1702 E. 1st Street in Pomona. To become a Certified Child Passenger Safety Technician, you must attend the entire four-day class, from 8:00 a.m. to 5:00 p.m. on the first 3 days, successfully complete hands-on skills testing during the class, and pass several written quizzes. The fourth day of the course (also required) is a safety seat checkup (9:00 am-3:00 pm) which will be held at the Petersen Automotive Museum in Los Angeles on Saturday, April 5.

The cost of the course is \$85 (Safe Kids registration fee). The course will be taught by a team of Certified Instructors with more than 60 years of experience in the field.

Although not required, we strongly encourage you to complete pre-requisites for the class - a one-day Educator Workshop (March 7, 8:15-4:30) and participation in a safety seat checkup. The date and time of the safety seat checkup have yet to be determined. These experiences are expected to facilitate participants' success in the Certification training. The one-day training and safety seat checkup also will provide tools for education in the community and a chance to see why the longer program is important for those who plan to work directly with the public in hands-on situations.

You also must create a user ID and register for the course with Safe Kids Worldwide, the Certifying Body. The \$85 fee must be paid to Safe Kids prior to the first day of class and can be paid by check, credit/debit card (Visa, MasterCard, Discover, or American Express), or a purchase order.
