# **Holdsport Privacy Policy**

#### 1. General

- 1.1 This privacy policy sets out how Holdsport Limited (hereafter referred to as "Holdsport") uses and protects any information that you give Holdsport when you use this website.

### 2. What we collect

We collect information from you when you register on our site or conduct an online search. When ordering or registering on our site, as appropriate, you may be asked to enter

- name and job title
- contact information including email address
- · demographic information such as postcode, preferences and interests
- phone numbers

# 3. What we do with the information we gather

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- To verify your identity when transacting on our site;
- To process requests: Your information, whether public or private, will not be given to any other company for any reason whatsoever, without your consent, other than for the express purpose of delivering the purchased product or service requested;
- To compile non-personal statistical information about browsing habits, click-patterns and access to the Website;

### 4. How do we protect your information?

- 4.1 We implement a variety of security measures to maintain the safety of your personal information when you make use of the website, and have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online, including but not limited to:
  - We offer the use of a secure server.
  - All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then
    encrypted into our Payment gateway providers database only to be accessible by those authorized with special
    access rights to such systems, and are required to keep the information confidential.

### 5. How we use cookies

- A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site.
- Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

- We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page
  traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical
  analysis purposes and then the data is removed from the system.
- Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful
  and which you do not.
- A cookie in no way gives us access to your computer or any information about you, other than the data you
  choose to share with us.
- You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can
  usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full
  advantage of the website.
