RESIDENTIAL TEMPORARY RELEASE FORM

Effective November 16, 2003, International Residential Code (IRC) Section E 3601.8 of Virginia Uniform Statewide Building Code (USBC) allows for the temporary release of **residential** electrical services for **construction purposes only**, when the following conditions are met:

- _____ 1. The service wiring and equipment, including the meter socket enclosure, shall be installed and the service wiring terminated.
- _____ 2. The grounding electrode system shall be installed and terminated.
- _____ 3. Grounding and grounded conductors shall be installed and terminated.
- _____ 4. At least one receptacle outlet on a ground fault protected circuit shall be installed and the circuit wiring terminated.
- _____ 5. Service equipment covers shall be installed.
- _____ 6. The building roof covering shall be installed.

THIS RELEASE IS TO COMPLETE CONSTRUCTION AND TEST EQUIPMENT ONLY, OCCUPANCY, TEMPORARY OR OTHERWISE, IS NOT PERMITTED UNTIL **ALL FINAL INSPECTIONS** HAVE BEEN APPROVED AND **THE CERTIFICATE OF OCCUPANCY** HAS BEEN ISSUED FROM THIS OFFICE.

The permit holder must sign, and has full responsibility not only to ensure compliance with these provisions but to assure safety on site once energized. Failure to comply with these provisions will result in revocation of the permit holder's right to invoke this requirement and depending on the circumstances; legal action by this office may be taken for violation of the USBC. If the building is occupied without a certificate of occupancy, the approvals granted above will be revoked, including the disconnection of the electrical service.
