MMA Task Force

- Objective
 - Improve timeliness, transparency, efficiency, and robustness of reference level processes
- Goals
 - Develop a process that addresses the mutual needs of Market Participants and the NYISO in administering reference level processes
 - Develop operational metrics that monitor success of process in achieving stated objective

Technical Bulletin

- Focuses on Reference Level and Mitigation Consultation processes
- Describes process for NYISO-initiated consultation/reference level updates
- Final draft reflects comments received to date
 - Note one correction to the Operational Metrics section, conforming the target for Urgent submittals to 16 hours
- Reviewed with MIWG on March 22
- To be posted for formal review period of 10 business days on NYISO website



Technical Guide

- Detailed discussion of major components of cost-based references
- Revised draft incorporates:
 - Comments received to date
 - Additional editorial modifications
 - Technical Bulletin material on consultation processes and timelines
 - Flowcharts capturing the high-level consultation processes

Additional Documentation

- Market Participants have raised for consideration the need for more formal documentation (i.e., tariff, Manuals) of Technical Bulletin/Technical Guide material
- MMATF should consider options in terms of content and form of any additional documentation and make recommendation to MIWG



Option "1" for Consideration

- Segregate consultation timelines from discussion of cost data elements
- Incorporate timelines in Administrative Practices Manual
- Maintain Technical Guide as standalone document focused initially on cost data discussion



Option "2" for Consideration

- Incorporate Technical Guide as currently structured as a Manual subject to BIC-approval
 - With consultation process timelines having been incorporated



Option "3" for Consideration

 Incorporating all or part of Technical Guide/Technical Bulletin into the NYISO tariff



Option "4" for Consideration

- Incorporating limited language in NYISO tariff cross-referencing NYISO procedures
 - Limited to consultation timelines



Open Discussion

- Identify "hybrid" options
- Identify other options
- Identify "pros" and 'cons" of each option
- Develop final recommendation for MIWG



Next steps

- Formal Report to MIWG
 - April 26th (tentative)
 - Summary of Activities
 - Review Technical Guide and Process Scorecard
 - Recommend form and content of any additional documentation requirements
- Begin tracking performance against targets
 - Quarterly reporting to MIWG


