## **Policies and Procedures**

### **Purpose and Goals**

It is the intention to schedule a BBQ contest that promotes a wholesome, family atmosphere and which appeals to all ages, interests and income levels. It is also our intention to provide an enjoyable event in which the entire community will feel welcome to participate.

### **Activity Classifications/Eligible Participants**

- All booth spaces are 12' X 12' (roughly) additional space is available at a discounted rate
- A CA Sellers Permit is required for anyone selling a product that is to be taxed
- No electricity will be available, bring your own (whisper variety) if you need to. Whisper generators must be approved to use before November 30th, 2012.

- Stadium lighting will be in use (if needed) during operation hours and load out

Arts & Crafts: Booth items that are 75% handcrafted by the contact person list on the application

Resale/Novelty: Booths with less than 75% handcrafted by the contact person or prepackaged foods

Commercial: Businesses wishing to exhibit their services or merchandise  
Food Sales: All food sold shall be provided by approved concessionaires and sponsors. Unless food vendor is also a participant in the BBQ contest, food vendor agrees not to sell BBQ Pork items, BBQ Beef items, BBQ Tri-Tip, BBQ Chicken and BBQ Brisket- In order for food vendor to sell BBQ items listed above he/or she must pay \$300 entry fee (space fee) for BBQ Contest, he or she may or may not elect to compete at that time. BBQ Hamburgers, Hot dogs, turkey legs, etc. (items not found in the competition) may be sold. All participants are subject to regulation by the County of Riverside Health Services Agency Department of Environmental Health. Food Vendors are NOT ALLOWED to sell alcohol (including Beer and Wine) at this event (a wine and beer garden spot must be purchased in order to do so). Food Vendors must have working fire extinguishers of a type approved by the Riverside County Fire Department in their booth at all times.

**ALL FOOD and Selected A&C/RESALE Vendors** must maintain **General Liability** in the amount of \$1 million covering the dates of participation. All insurance forms are due prior to November 22, 2012 (preferred with Vendor form if possible).

### **PERMIT PROCESS**

The application process begins when you submit your completed application and fees- due to the popularity of this event and limit of 100 vendors, first come first serve will be observed Please retain a copy of your application and policies and procedures for your records.

### **CONDITIONS**

All fees must be paid in full before confirmation is given. There is a \$25 service charge on all returned checks. Checks and Money orders should be made payable to **Fit2Go and mailed to: 21847 Grove Rd, Wildomar, CA. 92595 no later than 12/15/12**. Spaces are available on a first come first serve basis.

### **INDEMNIFICATION**
