# **CPR** and First Aid

# **Basic Cardiac Life Support for Healthcare Providers**

This course teaches basic life support (BLS) to healthcare professionals and rescue personnel. You will learn adult, infant, and child cardiopulmonary resuscitation (CPR) with the use of the automated external defibrillator (AED), training in rescue breathing with barrier devices and the use of bag-masks, as well as foreign-body airway management. You will receive a BLS Healthcare Provider card that is valid for two years after successfully completing the written exam and skills tests. You must attend the entire session to receive a card. This course is primarily for those working in the healthcare field (nurses, EMTs, respiratory, physical & occupational therapists, medical/nursing students, and other allied health personnel). For those looking for a basic CPR course, consider the Heartsaver AED course (CPR005). The course cost includes textbook, BLS for Healthcare Providers Student Manual. You should pick up your textbook and review it prior to the class. Books can be picked up at the WD&CE Customer Service desk at Gaithersburg or Takoma Park/Silver Spring between the hours of 9 a.m. and 5 p.m. Students that do not pick up their books will receive their book at the beginning of their class. Note: Students must be aware that classes may run longer than the posted times due to class size and/or other factors outside of the instructor's control. Courses may be cancelled due to insufficient enrollment. Half hour lunch break included in class time. Wear comfortable clothes and bring a towel or blanket for CPR practice. Tuition waiver applies; seniors pay fee only.

# Renewal Basic Cardiac Life Support (Healthcare Provider)

This course is ONLY for those who have a current American Heart Association Healthcare Provider card. This review allows AHA card holders to renew their training. Topics include one- and two-person rescue for the adult, infant & child; foreign body airway obstruction management; automatic external defibrillation (AED); barrier device; bag mask ventilation: etc. Your American Heart Association Basic Life Support Healthcare Provider cannot have expired; if it has, you are not eligible to participate in the class. You must bring the original card with you to class to present to the instructor. Upon successful completion of the class you will receive an American Heart Association BLS Provider card valid for two years. Note: Students must be aware that classes may run longer than the posted times due to class size and/or other factors outside of the instructor's control. Courses may be cancelled due to insufficient enrollment. Wear comfortable clothes and bring a towel or blanket for CPR practice. Tuition waiver applies; seniors pay fee only.

# **Heartsaver AED**

This course teaches members of the general public CPR techniques for use on adults, children and infants. The course also covers use of an AED (automated external defibrillator). Students learn how to relieve choking and how to use a barrier device. This course satisfies the CPR requirement for child care providers in the State of Maryland. Students will receive a course completion card that is valid for two years after successfully completing the written exam and skills tests. Students must attend the entire session to receive a card. **Note:** Students must be aware that classes may run longer than the posted times due to class size and/or other factors outside of the instructor's control. Courses may be cancelled due to insufficient enrollment. Wear comfortable clothes and bring a towel or blanket for CPR practice. Tuition waiver applies; seniors pay fee only.

# First Aid—Basic

This course teaches the citizen responder (and those who need a credential for employment) the principles of first aid, including how to handle emergencies in bleeding, shock, burns, muscle and bone injuries; sudden illness (allergic and diabetic reactions); poisoning; insect/animal bites; and heat- and cold-related emergencies. Simple hands-on bandaging and splinting procedures will be demonstrated. At the conclusion of this training and successful completion of practical skills and a written examination with a 70 percent or better score, a Basic First Aid certification card will be awarded with a suggested retraining date of three years from the American Safety and Health Institute. Textbook included. Tuition waiver applies; seniors pay fee only.

# Dialysis Technician Program A

Gain the knowledge and skills needed to work as a dialysis technician. Under the supervision of physicians and registered nurses, dialysis technicians operate kidney dialysis machines, prepare dialyzer reprocessing and delivery systems, and maintain and repair equipment. Technicians work with patients during dialysis procedures, monitor and record vital signs, and administer local anesthetics and drugs as needed. They also assess patients for any complications that occur during the procedure and must be ready to take necessary emergency measures like administering oxygen or performing basic CPR. Note: This program does not include a national or state certification as part of its overall objectives. Additionally there is no student internship or clinical rotation offered as part of this program. Tuition waiver applies; seniors pay fee only.

# EKG Technician **A**

Prepare to take the Electrocardiograph (EKG) Technician exam offered by the American Society of Phlebotomy Technicians (ASPT). EKG technicians work in physician offices, hospitals, clinics, and other health care facilities, and are responsible for performing electrocardiogram tests to monitor and record electrical impulses transmitted by the heart. This course includes background information on anatomy and physiology of the heart, medical disease processes, medical terminology, medical ethics, and legal aspects of patient contact. Learn the function and proper use of the EKG machine and the Holter Monitor, and demonstrate lead placement for a 12-lead electrocardiogram. Compare normal and abnormal EKG printed readings and measure various "peaks and troughs." Tuition waiver applies; seniors pay fee only.

## Professional Program A V

This comprehensive program will prepare students to handle patient encounters, patient customer service, and other areas related to intake and the coordination of a patient's healthcare experience. This program covers important background information on the healthcare profession including interpersonal skills, patient confidentiality, medical ethics and law, medical terminology, basics of insurance billing and coding, telephone techniques, scheduling appointments, and medical records management. Additional key program topics include customer service, referral/transfer services, resource scheduling, patient check-in, admission, registration, revenue cycle and information systems, statistical reporting, customer satisfaction and retention, leadership and management, and other relevant topics. Students who complete this program will be eligible to sit for the National Healthcareer Association (NHA) Certified Medical Administrative Assistant (CMAA) exam, the National Association of Healthcare Access Management (NAHAM) Certified Healthcare Access Manager (CHAM), or the Certified Healthcare Access Associate (CHAA) national certification exams, depending upon your professional experience level and other factors. # Pharmacy Technician Certification ▲♥

This comprehensive 72-hour course will prepare students to enter the pharmacy field and take the Pharmacy Technician Certification Board's PTCB exam. A GED or High School diploma is required to sit for the PTCB exam. Technicians work in hospitals, home infusion pharmacies, community pharmacies, and other health care settings—working under the supervision of a registered pharmacist. Course content includes medical terminology specific to the pharmacy, reading and interpreting prescriptions, and defining drugs by generic and brand names. Students will learn dosage calculations, I.V. flow rates, drug compounding, dose conversions, dispensing of prescriptions, inventory control, and billing and reimburse-

ment. Tuition waiver applies; seniors pay fee only.

## **English TEAS Prep Course**

This course is an intensive review to prepare you to take the English and Language Usage section of the Test of Essential Academic Skills (TEAS). Classroom activities will include a diagnostic test and a battery of practice tests which will familiarize you with the format of the exam and support your review of grammar, mechanics, punctuation, spelling, vocabulary, sentence structure, and word meaning in context. Isolated instruction in areas such as grammar, punctuation, direct dialogue, and types of sentences is provided. Instruction will be given in how to answer each type of question. Instruction will also be given in test-taking strategies, such as process of elimination and time-management. Two computerized tests which simulate the actual TEAS exams are provided, as well as a thorough review of each simulation. A baseline practice TEAS assessment is given to identify areas of weakness, so you are aware of areas to address in the class and for future review. You will have an opportunity to practice test-taking strategies such as process of elimination and time-management. Tuition waiver applies; seniors pay fee only.

## Nurse Refresher Classroom

This course is designed for RNs and LPNs who desire to maintain or re-establish their active license to reenter the nursing field. Nursing experts will present topics to review systems anatomy and physiology, major disease pathology, current treatment strategies and legal issues, pharmacology, physical assessment, nursing process, documentation, current trends, and endof-life issues. You must register for the classroom and clinical in order to use the payment plan. There is a non-refundable fee to participate in the payment plan. Tuition waiver applies; seniors pay fee only.

## Nursing Refresher: Clinical

- A. Nursing License: If your Maryland license has lapsed, you must apply for, pay for, and receive an inactive license. If you have an active license from any state other than Maryland, you must apply for and receive a Maryland license before starting your clinical. Please e-mail Tori Blackwell, the program director, for information tori.blackwell@montgomerycollege.edu.
- **B. CPR Certification:** This must be a healthcare provider-level course from American Heart Association or equivalent. Montgomery College provides this course at a special price for students. Please wait for information in the letter that will be sent once you register.
- C. 1. A complete physical exam, signed by your health provider, within 9 months of the start date for clinical. (You must use the Montgomery College Nurse Refresher Health Inventory form).
  - 2. Proof of immunity to the following diseases:

**Mumps, Measles (Rubeola) and Rubella:** Must provide serologic evidence that you are immune to Mumps, Measles and Rubella (positive titers). If blood titers are negative for any of these 3 diseases, you must receive two (2) doses of Mumps, Measles and Rubella vaccine (MMR) given 4 weeks apart. (Information documenting past MMR vaccinations is appreciated but cannot take the place of the titer test results.)

**Varicella:** Must provide serologic evidence that you are immune to Varicella (positive titers). If titers are negative, you are required to receive two (2) doses of Varicella vaccine given 4 weeks apart. (Documentation of childhood disease will not be accepted).

**Hepatitis B:** Three (3) doses of Hepatitis B vaccine given 0,1, and 6 months apart, followed by Hepatitis B surface antibody testing 1-2 months after dose #3 is required. If you cannot provide documentation of the 4-step vaccination process described above, you must obtain serologic evidence of immunity (positive Hep Bs Antibody titer). If this titer is negative for immunity, the vaccination series must be repeated.

**Tetanus, Diptheria and Pertussis:** Documentation of one (1) dose of Tdap vaccine (not to be confused with Dtap) in the past two (2) years, regardless of when the last Tetanus and Diptheria vaccine was given.

Influenza: Vaccine is to be given 1 month prior to the start date for clinical.

**Tuberculin Skin test:** (Mantoux Tuberculine test) within 9 months of the start date for clinical is required. If test results show TB exposure in the past or present, you must obtain clearance from your health provider that you are able to attend clinical. A chest x-ray may be needed. (Use the Montgomery College TB clearance form which will be provided with the Health Inventory Form when getting evaluated).

*Please note:* Vaccine series must be completed prior to clinical start date. All laboratory titers must have date blood was drawn as well as test results.

#### **Residency Policy**

The following are general guidelines taken from the College policy on residency for tuition purposes. A complete copy of the policy is available in the Montgomery College Catalog.

- A. Students attending Montgomery College will pay tuition according to their residency.
- B. To qualify, for tuition purposes, as a resident of the state of Maryland, legal domicile must have been maintained for a period of not less than three months prior to the first regularly scheduled class for the semester.
- C. The domicile of a person registering in a noncredit course at Montgomery College shall be considered as a person's permanent place of abode, where physical presence and possessions are maintained, and where he/she intends to remain indefinitely.

#### **Transfer Policy**

To transfer from one CRN to another CRN of the same course, a letter must be received in the Admissions, Records, and Registration Office, Montgomery College, 51 Mannakee Street, Rockville, MD 20850 before the beginning date of both CRNs of the course. If you have enrolled in a co-listed course you will have only one day after the class has begun to transfer. After that, you are committed to your path for the remainder of the course. If the course has a required assessment level to be a credit student, you must first complete the assessment testing and meet the appropriate assessment level before you can change to credit status.

#### **Refund Policy**

Refunds are paid at 100% for classes cancelled, dropped online, or in person (using a Drop Form), prior to the start date of the class. Refunds are also paid at 100% if class is dropped prior to the Refund Date printed on your registration confirmation.
