## **SCHOLARSHIP INFORMATION**

**Scholarship Focus:** Financial assistance to an individual(s) pursuing vocational training.

**Scholarship Amount:** The number of scholarships and the amounts will be determined annually by the Manatee Community Foundation. Payment will be forwarded by the Foundation directly to the educational institution for distribution. In addition to tuition, the scholarship may cover items such as books, equipment, lab or licensing fees, room & board, uniforms and other similar expenses associated with the student's coursework.

**Selection Criteria:** Scholarship applicants must –

1. Be accepted at an accredited vocational school.
2. Be a US citizen
3. Permanent residence or working in Manatee County.

**Application Deadline:** Completed applications forms must be returned or postmarked by July 1st to the Manatee Community Foundation office. Applications MAY NOT be faxed or e-mailed.

**Recipient Selection:** Scholarship recipients will be selected by the Manatee Community Foundation's *scholarship committee* based on the criteria stated above and a personal interview. In the event there are no qualified applicants, the scholarship will not be awarded that year.

**Scholarship Award Notification:** All applicants are notified in writing whether or not they received an award.
