

#### FROM THE PRESIDENT

Greetings everyone. It is that time of year again where we are looking for nominations for upcoming Association Officer positions. This year we will be filling the positions of President, Vice President of Retired Affairs and Secretary. Here is an excerpt from Article IV, Section 2 of the Bylaws on the qualifications for these positions:



"a. Only active duty chief warrant and warrant officers, who are Regular Members in good standing stationed in the Washington-Baltimore areas shall be eligible for nomination to the or hold the office of President and Vice President. If the President or Vice President is promoted to a grade higher than the rank of chief warrant officer, he or she shall be allowed to continue in the term of office to which elected, provide all other conditions of article IV, Section 2. a are met.

- b. Any regular member in good standing who is retired shall be eligible for nomination to or hold the office of Vice President of Retired Affairs.
- d. Any Regular Member stationed or residing in the Washington-Baltimore areas, in good standing, shall be eligible for nomination to or hold the offices of Secretary or Treasurer."

I have had the honor of serving the Association as both President and Vice President and it has been a very rewarding experience. For our Association to remain strong, it is important to have motivated members serving on the Board of Directors. I encourage members to contact me or the Association Office if you are interested in one of the positions or would like more information. Nominations need to be delivered to the Nomination Committee by I December, 2011.

## Women's Center Recognizes Volunteers



On Thursday morning, 6 October, it was my distinct honor & privilege to attend the Annual Meeting and Recognition Breakfast for the Women's Center of Southeast CT. This annual event is a chance to review milestones of the past year and to recognize all of the volunteers who contributed to the betterment of the Women's Center. During the meeting, an Advocate from the Court read a very emotional letter from a mother of four who was directly impacted by domestic violence - and who was assisted by the Women's Center.

Last year, 183 people volunteered at the Women's Center - and CWOPD Class 04-11 and CWOPD Staff is a significant percentage of the 183 people who have volunteered. The emergency shelter, Genesis House, averaged 101% capacity for the entire year. This means that battered women often had to sleep on sofas and small kids had to sleep in pack-n-plays. This 101% capacity represents the highest occupancy level ever in the history of the Center.

CWOPD 04-11, among other things, accomplished a phenomenal "extreme home makeover" at Genesis House by removing old and installing new kitchen cabinets and countertops over a 12-hour period. Additionally, "The Tile Man" - New York State Trooper - oversaw bathroom floor rehabilitation that resulted in rebuilding sub-flooring before a toilet and bathroom vanity could be re-installed over a new deck of tile. Our work, in that single evolution, represented well over 200 hours of Community Service. That same day, after our work was completed, the residents of Genesis House arrived "home" in tears of joy when they saw the finished product. This one single day was recognized by the Women's Shelter as the 2nd most significant community service project of the year!

I humbly accepted a certificate of recognition from the Women's Center, but I accepted it under very clear acknowledgement that it is YOU ALL - CWOPD Class 04-11 - that made this possible! As your former instructor and a Chief Warrant Officer peer, I respect and stand in awe of the great talent that you and every CWOPD Class brings to the LDC. I hope you are as proud of what you accomplished as I am proud of you.

As you reflect back on your accomplishments here in New London, I hope that you will continue to do great work for the communities in which you now serve. Whether you are a single volunteer or you coordinate a group effort through your unit or local Chapter of the CWOA, I challenge you all to share your talent, share your leadership and share your passion.

Your communities and this organization benefit by your actions.


## Long Island Sound Chapter Members Assist Local Habitat for Humanity

## Chief Warrant Officer John A. Keller CWOA Scholarship Grant

#### **Eligibility Requirements**

An applicant must meet the following eligibility requirements:

- a. Be the dependent son/daughter of a member in good standing of the Chief Warrant and Warrant and Warrant Officers Association or who was a member in good standing at the time of their death.
- b. Be a senior in high school with an average of "C" or better during the most recent two semesters or be currently enrolled in an accredited institution of higher learning with an average of "C" or better for the year immediately prior to application.
- c. Be enrolled in a full time course of instruction.
- d. The financial status of the applicant's parents shall not be a factor in determining the applicants to be awarded grants.
- e. The receipt of a grant does not exclude an applicant from receiving additional grants in subsequent years.

#### **Application Instructions**

- a. Applications shall be submitted to the Association office (CWOA, 200 V Street SW, Washington, DC 20024), postmarked not later than 1 March and must be received by the Association not later than 15 March each year.
- b. Applicants shall submit with their reason(s) for attending or desiring to attend an accredited institution of higher learning above high school. Submissions shall be limited to two hand-written pages or one typed page and must specifically include immediate and long-range goals.
- c. Applicants who have not completed one or more years at an institution of higher learning shall furnish a certified copy of his/her scholastic record beginning with the tenth grade. Applicants who have completed one or more years at an institution of higher learning shall furnish a certified copy of his/her scholastic record while attending institutions of higher learning.
- d. Applicants shall furnish a copy of a letter of acceptance from their chosen college, university, vocational school, etc.
- e. Applicants are encouraged to submit supplemental documentation in support of any personal accomplishments, extracurricular activities, or community service performed during the past two years.
- f. Applicants are invited and encouraged to submit a head and shoulders photograph to be published in the CWO News if a scholarship grant should be awarded. The photograph will not be used by the Scholarship Committee in consideration of awarding the grant.


