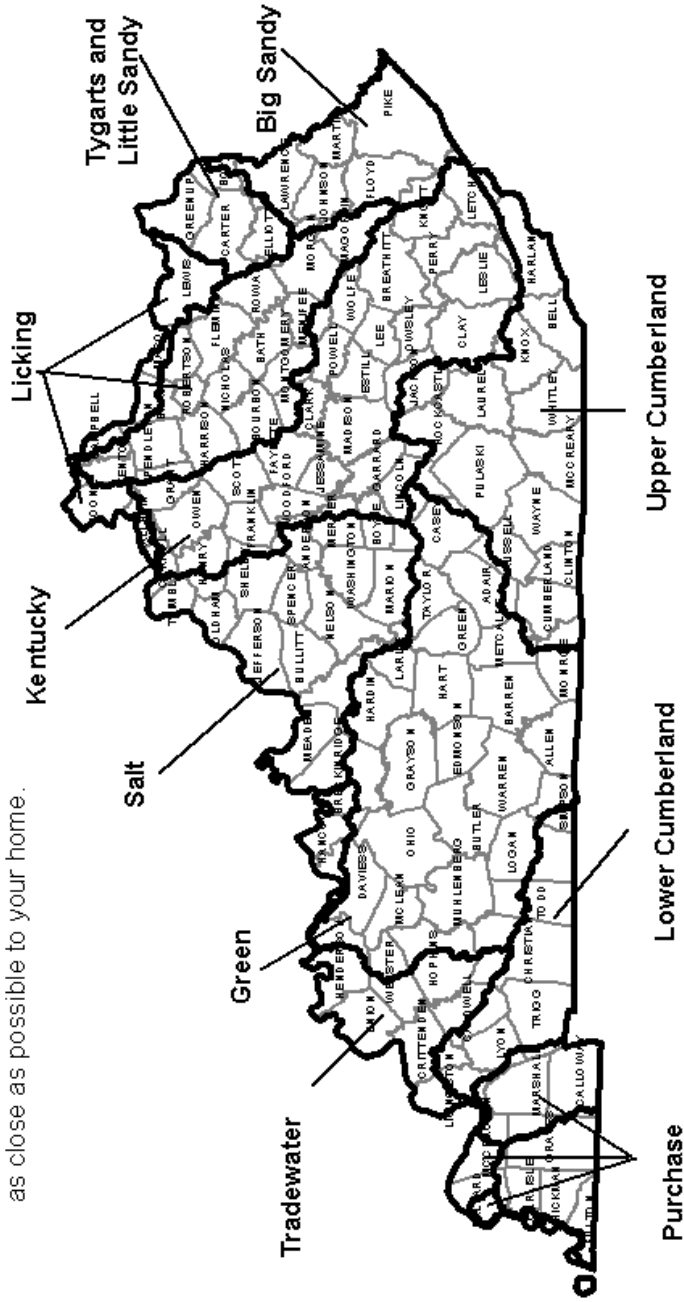

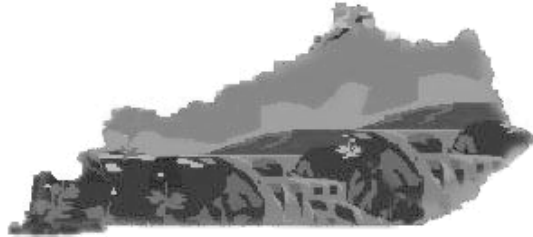

- *Floodplain Management and Community Liability: Seeking a Common Sense Approach to Watershed Protection* — The workshop will focus on watershed-based approaches to development, including the No Adverse Impact concept. The workshop will show how to integrate various programs at the local level and will address legal issues, such as community liability.
- *Comprehensive Commonwealth Water Education Project (CCWEP), Resources for Local Government Officials* (limit, 30 people) — Kentucky communities are growing and strive to prosper. The Kentucky Growth Readiness for Water Quality program helps communities learn how land use decisions affect water quality, comply with new regulatory requirements, and make informed decisions about managing growth.
