

# What BEACH House Is

## Help Families in Crisis

As professionals, we provide youth and their families opportunities and supports necessary to choose socially acceptable resolutions to meet their needs.

Our referral sources come from local school districts, Department of Children and Families, parents and other community members.

## Shelter

BEACH House shelter provides crisis shelter for youth ages 10 - 17 who display runaway, truant, and ungovernable behaviors. Families in conflict often need a break from each other. BEACH House provides a short time out period ( 10-14 days) which gives families an opportunity to cool off so they can begin to work on the family issues. The aim is to enhance family communication skills and reunification. Services include shelter, food, clothing, individual and group counseling, life skills, education, and referral. Our emphasis is on teaching conflict resolution and enhancing decision making skills.

## CINS - FINS

Children In Need of Services  
Families In Need of Services

Services are provided on a non residential basis to youth ages 10 - 17 who are runaway, truant, or ungovernable. Youth and their families are linked to a service manager who does an assessment of the issues. A plan is created that best fits the youth and family. Services include case monitoring, crisis counseling, referral, and linkages to services. Service Managers meet with the families once a month for approximately 12 weeks. There are no fees for any services provided.
