CONDITIONS

- 1. Fees for the academic year are as set out in the Fee Schedule. Fees are to be paid on semester basis.
- 2. Fees paid are neither refundable nor transferable, except in the circumstances set out below and provided that a request in writing for such refund is received by the Head of Department. Any refund of fees or part thereof, is subject to the following:
 - a) If a student withdraws from the programme before the commencement of the semester, an amount not exceeding 70% of all fees (except Registration Fee .ie Taylor's and UOT) paid is refundable.
 - b) If a student withdraws from the programme within the first two weeks after the commencement of the semester, an amount not exceeding 50% of all fees (except Registration Fee, ie Taylor's and UOT), paid is refundable.
 - c) There will be no refund of fees if a student withdraws after the second week of the commencement of the semester.
- 3. All fees due for each semester must be fully paid before or by the start date of the semester. An administrative charge of RM50.00 per week will be imposed commencing from the third week of the semester, up to a maximum of RM150, if payment is not received by the specified due date for each week or part thereof delayed. The college reserves the right to review the status of the student and to take such necessary action as the College deems fit if payment is not received by the end of the fifth week of the semester. Such action may include the suspension or termination of the student.

- 4. In the event that the College cannot accept a student for enrolment due to the fault of the College, all fees paid will be refunded in full.
- 5. In the event that a student is expelled from the College or leaves the College due to disciplinary/academic misconduct, there shall be no refund of fees paid except refundable deposits.
- 6. Refunds will be made in the name of the student.
- 7. All refunds whether of fees, deposits or whatsoever payments, shall be free of interest and shall be subject to the right of set off by the College against any fees or whatsoever payments due and owing to the College.
- 8. Students must abide by all academic, administrative and examination rules and regulations and policies of the College.
- 9. The College reserves the right to use a student's personal information in any publicity and/or promotion exercise of the College. The scope of usage of this information may include the publishing of good examination results, the award of a prize or scholarship, any achievement academic or otherwise and the granting of access to his/her information by the Taylor's College Alumni Association.
- 10. All claims for refund of any moneys (whether fees, deposits or whatsoever payments) shall be made within one (1) year from the date. The relevant student ceases to be a student of the College, failing which the amount thereof shall accrue in favour of the College and henceforth the right to so claim shall automatically cease. The College shall be entitled to transfer the said money into a separate account/fund and apply the same for whatsoever purpose deems fit by the College. All money refundable under the conditions under the conditions hereof shall be claimed by the student's/parent/guardian/sponsor within one (1) year from the date student ceases to be a student of the College, failing which the College shall be entitled to transfer the said money into a separate account/fund and be applied for whatsoever purposes deem fit by the College and further henceforth the parent/guardian/sponsor shall have no claim in respect of such money whatsoever.
