IMPORTANT NOTE: Please be advised that the u.s. passport office issues passports according to your departure date. Same day and 24-72 hour service is not always available. Our company is allowed to submit applications to the passport office each day before 10:30 am. In the event you are requesting that your application be submitted the day we receive it, please send your application by personal delivery or by an overnight courier that offers an 8 am delivery. Our company is allowed to process 3 passport applications on a same day/ 24-72 hours basis each day and 22 passport applications on any other service process. **if you need the passport to be considered for a same day process (\$50.00 additional special handling fee) or a 24 to 72 hour rush process please fax us a copy of your documents and then give us a call so that we can review the documents – add your name to the rush process list and give you shipping instructions. You will be given a reservation number to hold your place in the lineup for pptg to submit your application accordingly, be sure to list the reservation number on the work order. Failure to follow any of these instructions will cause a delay. Passport photos to go is not responsible for delays out of our control. If in event the passport office denies your application, pptg service fees are non-refundable and will be charged according to original request.

REQUIREMENTS TO EXPEDITE A MUTILATED U.S. PASSPORT

PLEASE FOLLOW THESE INSTRUCTIONS IF:

YOUR CURRENT PASSPORT HAS BEEN DAMAGED IN ANY WAY THAT MAY CAUSE PROBLEMS WHEN YOU TRAVEL (e.g. DAMAGED IN THE WASHING MACHINE, PAGES RIPPED OUT, LAMANATION COMING OFF, ETC.)

TAKE THE BELOW MENTIONED DOCUMENTS TO AN ACCEPTANCE AGENT.

CLICK HERE TO FIND YOUR LOCAL ACCEPTANCE AGENT NEAREST
YOU.REQUEST THE AGENT TO EXECUTE YOUR DOCUMENTS AND PLACE THEM
IN A SEALED ENVELOPE. ADVISE THE AGENT THAT YOU ARE HAVING VIP
SERVICES WALK YOUR PASSPORT APPLICATION THROUGH THE STATE
DEPARTMENT. SEALED ENVELOPES MUST BE PRESENTED TO THE STATE
DEPARTMENT WITHIN (5) FIVE WORKING DAYS OF BEING SEALED.

- APPLICATION (DS-11) ONLINE. ONCE YOU HAVE COMPLETED THE FORM, YOU MUST PRINT OUT 2 COPIES BY CLICKING ON THE CREATE FORM BUTTON. FAILURE TO DO SO WILL CAUSE A DELAY. DO NOT SIGN THE APPLICATION UNTIL ASKED TO DO SO BY THE PASSPORT ACCEPTANCE AGENT.
- * WHEN COMPLETING THE APPLICATION BE SURE TO LIST VIP SERVICES INFORMATION IN THE MAIL PASSPORT POSITION
- * PLEASE ATTACH THE $2^{\rm ND}$ COPY OF THE RELEASE LETTER TO THE OUTSIDE OF THE SEALED ENVELOPE ALONG WITH THE $2^{\rm ND}$ COPY OF THE PROOF OF DEPARTURE AND THE PPTG WORK ORDER REQUEST FORM.
- 2.) (2) TWO COLOR PASSPORT TYPE PHOTOGRAPHS (2"x2"). THE HEAD IS MEASURED FROM BOTTOM OF CHIN TO THE TOP OF THE HAIRLINE AND SHOULD BE BETWEEN 1 INCH AND 1 3/8 INCHES, TAKEN WITHIN THE PAST (3) THREE MONTHS. BE SURE THAT THE PHOTOGRAPH IS TAKEN WITH A WHITE BACKGROUND.
- 3.) AN ORIGINAL <u>CERTIFIED BIRTH CERTIFICATE</u> ISSUED BY THE STATE OR COUNTY WHERE YOU WERE BORN. YOU MAY USE AN <u>EXPIRED PASSPORT</u> IN LIEU OF A BIRTH CERTIFICATE.

 NATURALIZED CITIZENS WILL USE THEIR <u>NATURALIZATION</u>
 CERTIFICATE IN LIEU OF A BIRTH CERTIFICATE.

4.) A WRITTEN LETTER, BY THE APPLICANT, EXPLAINING HOW THE PASSPORT WAS DAMAGED.

5.) PASSPORT BOOK FEES:

 $\frac{\$170.00}{(\$110.00)}$ PAYABLE TO THE "DEPARTMENT OF STATE", (\$110.00) PASSPORT FEE + \$60.00 EXPEDITE FEE = \$170.00) PLUS A \$25.00 EXECUTION FEE.

CONTACT THE ACCEPTANCE AGENT FOR METHOD OF PAYMENT.

AN ADDITIONAL \$30.00, ALSO MADE PAYABLE TO THE

DEPARTMENT OF STATE, WILL BE REQUIRED WHEN APPLYING FOR

A PASSPORT CARD AT THE SAME TIME.

- 6.) YOU WILL BE REQUIRED TO SHOW YOUR VALID DRIVERS LICENSE OR STATE ISSUED IDENTIFICATION. IF YOU CANNOT PROVIDE ACCEPTABLE I.D., PRESENT AS MANY DOCUMENTS AS POSSIBLE, DATING BACK AT LEAST 5 YEARS.
- 7.) WITHOUT PROOF OF DEPARTURE THE STATE DEPARTMENT WILL PROCESS YOUR PASSPORT IN APPROXIMATELY 25 WORKING DAYS. INCLUDE ONE OF THE FOLLOWING INSIDE YOUR SEALED ENVELOPE:
 - A.) A CONFIRMED ITINERARY,
 - B.) A COPY OF YOUR AIRLINE TICKETS or
 - C.) AN ORIGINAL COMPANY LETTER OF EXPEDITE
- 8.) YOU MUST COMPLETE AND INCLUDE TWO COPIES OF THE RELEASE LETTER AUTHORIZING VIP SERVICES TO COLLECT THE PASSPORT ON YOUR BEHALF. ONE COPY OF THIS LETTER, WITH ORIGINAL SIGNATURE IN BLUE INK, SHOULD BE PLACED INSIDE THE SEALED ENVELOPE BY THE PASSPORT ACCEPTANCE AGENT AND THE OTHER SHOULD BE ATTACHED TO THE OUTSIDE OF THE ENVELOPE. IF A RELEASE LETTER IS NOT INCLUDED INSIDE THE SEALED ENVELOPE, THE PASSPORT WILL BE MAILED TO THE ADDRESS LISTED ON THE APPLICATION.
- 9.) A COMPLETED VIP SERVICES WORK ORDER FORM SHOULD BE ATTACHED TO THE OUTSIDE OF THE SEALED ENVELOPE.
- 10.) A COMPLETED VIP SERVICES PASSPORT INSTRUCTION SHEET.

- 3.) CERTIFIED COPY OF BIRTH CERTIFICATE OR NATURALIZATION CERTIFICATE OR YOUR OLD EXPIRED PASSPORT
- 4.) \$170.00 OR \$200.00 PAYMENT (PAYABLE TO THE "DEPARTMENT OF STATE")
- 5.) ORIGINAL RELEASE LETTER
- 6.) PROOF OF DEPARTURE (ITINERARY OR COPY OF AIRLINE TICKETS)

IMPORTANT NOTE: PLEASE BE ADVISED THAT THE U.S. PASSPORT OFFICE ISSUES PASSPORTS ACCORDING TO YOUR DEPARTURE DATE. SAME DAY AND 24 -72 HOUR SERVICE IS NOT ALWAYS AVAILABLE. OUR COMPANY IS ALLOWED TO SUBMIT APPLICATIONS TO THE PASSPORT OFFICE EACH DAY BEFORE 10:30 AM. IN THE EVENT YOU ARE REQUESTING THAT YOUR APPLICATION BE SUBMITTED THE DAY WE RECEIVE IT, PLEASE SEND YOUR APPLICATION BY PERSONAL DELIVERY OR BY AN OVERNIGHT COURIER THAT OFFERS AN 8 AM DELIVERY. OUR COMPANY IS ALLOWED TO PROCESS 3 PASSPORT APPLICATIONS ON A SAME DAY/ 24-72 HOURS BASIS EACH DAY AND 22 PASSPORT APPLICATIONS ON ANY OTHER SERVICE PROCESS. **IF YOU NEED THE PASSPORT TO BE CONSIDERED FOR A SAME DAY PROCESS (\$50.00 ADDITIONAL SPECIAL HANDLING FEE) OR A 24 TO 72 HOUR RUSH PROCESS PLEASE FAX US A COPY OF YOUR DOCUMENTS AND THEN GIVE US A CALL SO THAT WE CAN REVIEW THE DOCUMENTS - ADD YOUR NAME TO THE RUSH PROCESS LIST AND GIVE YOU SHIPPING INSTRUCTIONS. YOU WILL BE GIVEN A RESERVATION NUMBER TO HOLD YOUR PLACE IN THE LINEUP FOR PPTG TO SUBMIT YOUR APPLICATION ACCORDINGLY. BE SURE TO LIST THE RESERVATION NUMBER ON THE WORK ORDER. FAILURE TO FOLLOW ANY OF THESE INSTRUCTIONS WILL CAUSE A DELAY. PASSPORT PHOTOS TO GO IS NOT RESPONSIBLE FOR DELAYS OUT OF OUR CONTROL. IF IN EVENT THE PASSPORT OFFICE DENIES YOUR APPLICATION PPTG SERVICE FEES ARE NON-REFUNDABLE AND WILL BE CHARGED ACCORDING TO ORIGINAL REQUEST.
