MAKING YOUR GIFT GO FURTHER WITH GIFT AID

Gift Aid is a simple scheme that enables Barnard Castle School to reclaim the basic rate of tax on donation received from UK taxpayers, meaning that for every £1 you donate is worth £1.25 to the School.

In addition, donors who pay a higher rate of tax are able to reclaim the difference between the higher rate and the basic rate in their Self-Assessment Return, bringing the cost of your gift down to 75 pence in the pound while still making the gift worth £1.25 to the School. If you are a UK tax payer, please complete the declaration on the front of this form.
