2. Scholarship students will be required to attend classes regularly. **Attendance of less than 2/3 of scheduled classes could result in loss of scholarship.**
3. Scholarship parents will be required to volunteer for every performance in which their dancer participates. Payment in lieu of volunteering will not be accepted.
4. All parents are required to sell one (1) book of raffle tickets during each of our two annual raffle ticket sales.
