- 5.3 If you did not receive federal aid at Miles College, but you did receive federal aid at another college, please contact the Federal Student Aid Processing Center and add the Miles College Federal Pell Grant school code to your Free Application for Federal Student Aid for the 2011-2012 school year, so that the College can receive your FAFSA/ISIR record. The Federal Pell Grant Code for Miles College is 001028. The telephone number for the Federal Student Aid Processing Center is 1-800-433-3243. Also, you may use the PIN number assigned to you by the Federal Processing Center to return to your file at the website www.fafsa.ed.gov and add Miles College to the list of schools you want to receive your Free Application for Federal Student Aid record.
