#### PRESIDENTS MESSAGE

On behalf of WMTA, I want to thank all the speakers, sponsors, and attendees at the 2011 WMTA Annual Meeting. As always, the meeting provided a wealth of information for those interested in a better West Maui, and this year there was also considerable information on efforts to improve Hawaii's economy.

District 10 Representative Angus McKelvey explained that the legislature was focusing on JOBS, JOBS, JOBS. That is certainly what a taxpayers organization likes to hear, but the news out of the Capital seems more focused on sucking all the energy out of the economy by taxing pensions and HOA dues and anything else that might be taxable.

In sharp contrast to the State, Mayor Alan Arakawa gave a reasoned and insightful preview of his efforts to thoughtfully and rationally right-size County government. WMTA will be there to represent the taxpayer, and to urge government to spend your tax dollars wisely.

The West Maui Taxpayers Association and West Maui Improvement Foundation, amongst other organizations collaboratively worked together with the County Parks Department to bring the skatepark to reality. All that remains is the Notice to Proceed and building should commence.





#### <u>K2020 – WEST MAUI HOSPITAL UPDATE –</u> <u>JOSEPH PLUTA</u>

It seems that a new site for the proposed West Maui hospital will permit expedited permitting and approvals. According to Kaanapali Land Management Corporation, at this time there is an agreement being negotiated whereby the site for the West Maui Hospital and Medical Center will be relocated outside of the Pu`ukolii Triangle and will be located closer to the Hoonoapiilani Highway.

It is encouraging that Newport Hospital Corporation/Brian Hoyle and the landowner have agreed to withdraw the request to HHFDC to build the hospital in the Pu`ukolii Triangle. That removes its jurisdiction away from the State of Hawai's HHFDC and will permit local County control.

The Maui Mayor has indicated his enthusiastic support and the cooperation of this staff and planning department. The new location will be off of Kaka`alaneo Drive on the left side as you drive up a few hundred yards from Honoapiilani Highway.

#### TRANSPORTATION SUMMARY - BOB PURE

We are happy to report that there is much good news regarding transportation issues affecting West Maui. First of all, the intersection of Keawe St. and the highway has been reconfigured to include a dedicated left turn lane coming out of the Lahaina Gateway shopping center. This has gone a long way to easing congestion in that area. As you know, the "highway widening" project (from Lahainaluna Rd. to Aholo St.) has also been completed, expanding the roadway to two lanes in each direction and adding a landscaped tree-lined median down the center. There is now a marked difference in traffic flow, all positive, coming in and out of Lahaina.

Our major project, construction of the long awaited Lahaina Bypass is moving ahead on schedule on both Phases (Keawe Street to Lahainaluna Rd and Lahainaluna Rd to Hokiokio St.) Target completion date is late summer/early fall of 2012. The plan from both contractors is to have both Phases completed at the same time.

When these two Phases are done, motorists will be able to "bypass" Shaw, Dickenson, Lahainaluna and Papalaua Sts. in each direction.
