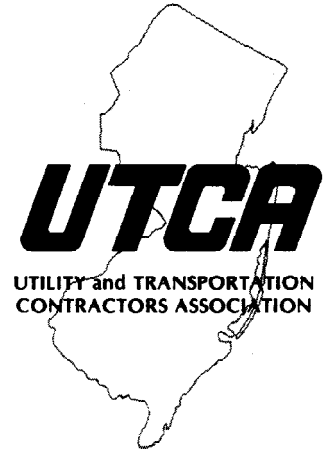


# UTCA Construction Safety Seminar

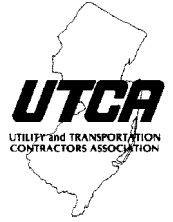
