Shipping YOUR BIKE to IZMIR, TURKEY in 2015

1 December, 2011

As shipping agents Get Routed offer the following shipping service - for 2015 there will be one shipment from Australia – ex Melbourne, ex Sydney, ex Brisbane & ex Perth – all subject to full containers – minimum 10 bikes. If there's not enough bikes (or too many) at any Aust port for a viable shipment the bikes will have to go to another port for loading, at the owner's expense.

Please note: Bike owners must be in Izmir on Monday 13 April at 9am for the Customs Clearance process with Bike rego papers and a current passport. No exceptions. You must be present to have your bike Customs Cleared.

collect your bike in Izmir, Turkey on Monday 13 April at 9am

Easter Sunday is 5 April **ANZAC Day is Saturday 25 April** 

#### return shipment loading Felixstowe, UK Thursday 16 July at 9am

Alternative return shipments could be loaded in Felixstowe in Aug. Sept or Oct - all subject to minimum of 10 bikes.

PLEASE NOTE: A container is 2.30 metres wide and because we place the bikes across the width, bikes longer than 2.30m attract a higher price. With some long bikes we are able to shorten them by taking out the front wheel, putting the axle back in the forks and loading them the same as the other bikes (with the front axle in a rubber lined steel chock), thus saving you 1000 Beer vouchers. BUT bring your tools and do it yourself, we don't mess with your bike, you do! We will arrange for a forklift to pick up the front of your bike for front wheel removal.



#### TERMS and CONDITIONS for shipping Australian bikes to Izmir and back from Felixstowe

Failure to read, understand and act upon these Terms and Conditions could cause you considerable heartache and expense!!

**1. Bike Cleanliness**. Your bike must be spotless when packed into the container at both ends - this is a Quarantine Service requirement YOU HAVE BEEN WARNED. It is your responsibility to arrange cleaning of your bike prior to the return journey.

2. PETROL TANKS must be empty of fuel. A small amount of fuel (less than 2 litres) in the tank sufficient to get you to the nearest servo is acceptable.

**3**. All bikes must have their **BATTERY TERMINALS DISCONNECTED** and **TAPED** prior to shipping in Australia and Felixstowe. This is your responsibility.

**4.** All **Fixed Panniers** must be disconnected from the bike prior to loading, but they will be carried in the container. We will take all care possible but are not responsible for any damage during shipping so please wrap appropriately. Suggestion - Use 2 OR 3 layers of plastic Bubble wrap. Label each item – name & bike rego number.

5. The prices quoted do not include the cost of your tour within UK/Europe/Turkey.

**6**. These prices are valid from 1 December 2011 and are based current freight rates and other cost components at that time. Any cost increases will be passed on when invoices are prepared in January 2014.

7. It is each rider's responsibility to be at the Felixstowe depot on the dates provided. The Felixstowe DEPOT address will be supplied prior to loading.

8. We will organise the Customs clearances, all paperwork and loading/unloading of the container. Bike owners **must** be in Izmir on Monday 13 April at 9am for the Customs Clearance process with Bike rego papers (originals) and a valid passport. This is a very important condition of this shipment and your acceptance is a big commitment to every other bike owner in this shipment – all bikes will be Customs Cleared and released at the same time – one owner not present will cause the whole shipment to be held until all owners are present.

**9**. Your \$600 deposit is NON REFUNDABLE. We may be able to roll it over to a later tour/shipment or refund it if you can encourage someone else to take your place, obviously at the discretion of Get Routed.

**10**. We require your bike approx 4 days prior to the shipping date and shipment of your bike from Australia is between 28 and 35 days. You will be advised date and address to deliver your bike to the Melbourne/Sydney/Brisbane depot prior to loading.

11 Bookings will not be accepted without a deposit (\$600) and a completed RESERVATION FORM.

12. The balance of the cost is due not later than 4 weeks prior to the SHIPPING DATE of your bike. An invoice will be sent.

13. Reservations will not be accepted within 6 weeks of a shipping date except under circumstances such as a cancellation.

**14.** Your passport will be needed to provide proof of ownership to depot staff in Izmir to collect your bike. This is required to ensure no one else has access to your bike in our Felixstowe depot. Without your passport no one can claim your bike.

**15.** If we don't have sufficient bikes for any particular return shipment your bike may not go back to the Australian port from which it was shipped. Decisions will be made prior to departure from Australia.

Insurance for your bike in Turkey. When you arrive to collect your bike the Turkish Insurance will be purchased – it's compulsory and covers 3<sup>rd</sup> party property.

Loading date to be advised when the shipment is full. We require your bike approx 4 days prior to the shipping date and shipping from Australian ports takes between 30 days and 39 days. Loading dates in February are subject to shipping schedules

#### DAMAGE TO MOTORCYCLES and ACCESSORIES

As part of our agreement with you we will make good Loss or Damage that occurs to your Bike or included accessories in excess of an amount of \$250.00, which is your responsibility. The Loss or Damage that we accept is any Loss or Damage, or other Liability that may arise from the voyage, which would be covered by Marine Insurance Institute Cargo Clauses "A". In other words, we have insurance in place to cover us and our liability in respect of all bikes in the shipment and the excess, should there be a claim, is your responsibility.

You can ride your bike in the UK/Europe on your Australian Registration plate for up to 6 months (subject to your Aussie rego being current for that time) and using your current Australian licence for up to 3 months. An International Driving Permit (for up to 12 months) is advisable if you're staying beyond 3 months. The IDP is necessary if you're touring Europe because it's really just a translation of your Aussie licence.

**Riding Insurance in UK & EU Countries** We are in contact with an insurance company who may be able to provide Fully Comprehensive cover for your bike while in the UK & Europe. We will send your requirements to them 1 month prior to loading so that your bike will be covered before Customs Clearance in Turkey – Insurance cover is compulsory in the UK & Europe and is part of the Clearance process.
