- ❑ **Completed application.**
- ❑ **Official or certified university transcript showing all university courses taken in the past with grades; include a list of courses in which you are currently enrolled.**
If transcript is not in English, it must be accompanied by a certified translation.
- ❑ **Photocopy of your passport identification pages (those with your full legal name).**
- ❑ **Original financial documents from a bank or broker verifying financial support of USD \$7,185 for the Fall 2014 semester or \$14,370 for the 2014-2015 academic year.**
Photocopies or certified copies will not be accepted! U.S. government stipulates original documents only!
- ❑ **Letter from your university verifying your English language ability or a certified copy of your TOEFL or IELTS score report.**
Please note that this is required only if English is not your native language or if the language of instruction at your home university is not English.

personal statements/essays
letters of recommendation
your home university's study abroad application

NOTE: Some 500- and all 600-level courses are graduate courses and are not available to students on undergraduate exchange programs. When prerequisites have been met they are open to graduate students.
