- Original financial documents from a bank or broker verifying financial support of USD \$7,185 for the Fall 2014 semester or \$14,370 for the 2014-2015 academic year. Photocopies or certified copies will not be accepted! U.S. government stipulates original documents only!
- Letter from your university verifying your English language ability or a certified copy of your TOEFL or IELTS score report.

Please note that this is required only if English is not your native language or if the language of instruction at your home university is not English.

personal statements/essays letters of recommendation

your home university's study abroad application
