Construction shall not proceed past the point of an approved slab or footing inspection (which includes rough slab plumbing) and concrete placement completion until an **as-built elevation certification**, prepared by a Registered Land Surveyor, of the lowest finished floor, including basement, has been submitted to and approved by the Storm Water Management Division of Public Utilities. The lowest finished floor, including basement, shall be constructed above the 100-year floodplain elevation as follows:

- Three (3) feet above** (residential)
- One (1) foot above** (nonresidential)
- At or above the 100-year **regulated** floodplain elevation
