# FOUNDATION MISSION

The mission of the ISSA Foundation is to raise and provide funds for scholarships, research grants, and other programs that promote the welfare of the general public as it relates to the sanitation, cleaning, and maintenance industry.

This mission is accomplished through generous donations from individuals and companies, most of whom are ISSA members. Contributions support the annual scholarship program and are tax deductible.

Since the inception of the scholarship program, more than 900 scholarships have been awarded, totaling more than \$2.2 million. Employees of member firms and their family members are encouraged to apply.

# GENERAL FUND

Individuals or companies may donate any amount to the General Fund at any time. The names of all donors are published in the Foundation's Annual Report, and donations of \$100 or more are published in *ISSA Today* magazine.

## TYPES OF AWARDS

### General Scholarship Program

\$3,000 are awarded from the General Fund each year. Recipients must be attending four-year academic institutions in undergraduate or graduate work as full-time students in the fall of the award year.

### Scholarship Sponsor Program

The Scholarship Sponsor Program enables an ISSA-member firm to sponsor a District Scholarship Award for a single donation of \$3,000. The company may select a district scholarship to be awarded in its name. A scholarship in the name of your company may encourage today's young leaders to seek careers in the cleaning and maintenance industry.

The application must be postmarked by April 1.

## UID SCHOLARSHIP PROGRAM

The ISSA Foundation issues up to five scholarships annually in the amount of \$995 each. The awards cover the registration fee to attend the University of Industrial Distribution (UID).

UID is a four-day concentrated educational program focused on the unique needs of the industrial wholesale distribution industry. Visit [univid.org](http://univid.org) for more detailed information.

## DESIGNATED FUNDS

### **FUND ESTABLISHMENT**

To establish a Designated Scholarship Fund:

- An initial gift of \$3,000 must be received with a statement of intent to establish a Designated Fund.
- Accumulated contributions must reach \$15,000 by the end of the calendar year following the third anniversary of the initial contribution.
- Awards may not be made from a Designated Fund until the Fund has achieved an initial total of \$15,000 balance on hand.

### **SELECTION PROCESS OPTIONS**

Designated Scholarships may be awarded as follows:

- To a qualified applicant sponsored by an ISSA-member firm for the college of the student's choice.
- To a qualified applicant for a specific university; the college prescreens the applicants.
- To a graduate of a specific high school; the high school prescreens the applicants
