Cottage Vacation Rentals has CONFIRMED a reservation, the named person on the form will be responsible for the TOTAL RENTAL AMT. as agreed. The remaining balance of agreed rental cost must be paid 30 days prior to arrival. If the full balance is not paid in accordance with these booking conditions, we reserve the right to cancel your booking and under these circumstances your reservation deposit will be forfeited.

**SECURITY DEPOSIT:** A refundable security deposit of \$150.00-\$250 is added to the Total Rental Amount and will be refunded to the person named on this form to the address listed upon inspection of the cottages after departure. We reserve the right to charge any damages to the contents of or the cottages themselves without advance notice. In the event of excess damage, the named person on this booking form will be held responsible for all costs of repair. Please, enjoy our cottages, but please return them to us undamaged. **CANCELLATIONS:** Once a Seasonal Rental Agreement is completed and deposit paid, the following policy applies to all cancellations regardless of reason: Cancellation 60+ days notice: Refund of deposit less a \$150 cancellation fee. Cancellation with 59 days or less: No refund due unless we are able to re-rent the cottage for the original reservation dates. If re-rent is possible, any difference, in rate and a \$150.00 cancellation fee will be withheld from deposit. If reservation is made within 30 days of arrival and then canceled, no refund will be provided. SunTiki Cottages Strongly recommends the purchase of travel insurance especially if traveling during the known hurricane season, which runs between June 1 and November 30 of each year. Travel Insurance can be purchased online at www.travelex-insurance.com or by calling 1-800-228-9792.

**RESPONSIBILITIES:** All persons on this booking form are responsible for the care of the property and its contents and are fully expected to take reasonable care of including the locking of all doors and emptying the trash each evening. Failure to comply will render the booking void and no compensation will be paid.

**SMOKING AND PETS**: Smoking is allowed outdoors only and we ask that all cigarettes be disposed of properly to maintain a clean beach atmosphere. Smoking inside any SunTiki Cottage will result in the loss of security deposit. Due to the nature of the beach and a lack of places to walk a pet, pets are not permitted inside any SunTiki Cottage.
