- 6. Horse trailers/vehicles to be parked in designated equestrian area, away from ball diamond fence.
- 7. Horses and horse activities to remain in designated horse use areas ie. no wandering through playground, upper parking lot, fitness trail, etc.
- 8. If it poops, scoop please scoop poop from arena and deposit in designated area. Shovel and wheelbarrow will be provided and must be returned with key.
- 9. No feeding of animals in the arena
- 10. Arena is not to be used as a stable or overnight corral
- 11. No harrowing the arena unless pre approved to do so
- 12. Minors will be supervised by adults in charge
- 13. Dogs must be on leash
- 14. Power is available at the announcers stand (upstairs) for speaker systems and timers only
- 15. Insurance waivers, attached, must be signed prior to event. These Insurance waivers are valid from January 1 to December 31 and must be renewed annually. Applicant must ensure all participants sign insurance waivers prior to event.
