afo	resaid circumstances the said Attorney is empowered:
1.	To apply for loan from Dewan Housing Finance Corporation Limited for the part financing to
	purchase the aforesaid property.
2.	To pay the Processing Fees and sign the requisite Loan Application in my name and on my
	behalf and to furnish all the details and information required by Dewan Housing Finance

Corporation Limited and to prepare any Statement/s, letter/s, and furnish any clarification/s,

Declaration/s, etc, or any other writing, if necessary, for getting the loan from Dewan Housing Finance Corporation Limited for me and on my behalf.

- To accept the offer letter of loan and to sign the acceptance thereof in token of the
