Competition Registration Packet

ATC is excited that your team(s) will be joining us for a 2008-2009 competition. Attached is the registration form for cheer and dance all star, school and recreational teams. Please complete the forms and mail or fax to the ATC office (Attn:Registration). We look forward to "Makin' it Fun" at your next ATC competition!

STEP 1

Please provide "Contact Information." All confirmation materials and schedules will addressed to this person and address. Confirmation materials will be sent out 2 weeks prior to an event. Schedules are posted online 1 week prior to an event.

STEP 2

The "Total Cost" of a team's registration will be calculated by participant fee, crossover fee, late fees and additional coaches. ATC allows 2 coaches FREE per team and requires that any additional coaches pay half of the participant rate. Please fill in the "Total Cost" boxes accordingly.

STEP 3

Payment information is required at time of registration. Please fax or mail in registration with appropriate payments: Visa, MasterCard, American Express, Discover (service fees may apply on credit cards), Check or Money Order. School purchase orders are also acceptable for team registrations. Please note that returned checks will incur an additional fee of \$40.

STEP 4

Please list all teams in appropriate divisions by writing participant and crossover numbers on page 3. Go to allthingscheer.com to find information regarding division requirements, time limits, specialty divisions and rules/regulations. ATC cheer and dance teams follow USASF rules. School and Recreation teams follow NFHS rules.

STEP 5

Every team is required to have one "code of conduct" signed by the head coach. Code of conduct's are due at the time of registration.

STEP 6

Please provide "team information" for every team registered. One page per team. Team information should include the name of the team as it will be announced at competitions as well as the names of the coaches for this team. Remember that ATC allows 1 coaches FREE per team. See step 2 for payment information.

STEP 7

The "team roster" should list every participant for that particular team. This should include the name of the participant, their date of birth and a shirt/jacket size. ATC national shirts and jackets are only given out at National Events.

Payments and Cancellations:

All payments must received at time of registration. Please contact the ATC office for procedures regarding deposits and late payments in order to avoid a late penalty. Payments received after the deadline posted on the ATC website will incur a \$50 per team late fee. Cancellations for any reason must be provided in writing 4 weeks prior to any event. No cancellations by phone. Refunds for balance paid in full will issued 4 weeks after the written cancellation is received.

| heck in at an event. Falsifying age and/or grade requirements will result in disqualification from competition. |
| I will accept all judges' decisions as final and not question the integrity of said judges. If there is a valid rotest, the head coach file a complaint. If, for valid purpose, I register a complaint, I understand that this |
| omplaint will be addressed after the competition. I understand that any action taken by a parent, family member, friend or competitor in approaching a ATC |
| taff member or judge will result in a penalty point deduction as well as forfeiting the coach's right to protest or eview tape. |

| I will promote fairness and demonstrate appropriate sportsmanship throughout the competition, as well as equire all persons affiliated with my program to conduct themselves with the same appropriate sportsmanship.
