Contractor shall provide assistance in filling Lube oil to rotary equipment, preparation of soln of chemical/s as per direction of concern SIC or his representatives on day to day basis. Shifting & placement of filled drums of Chemicals, Lube oils as well as washing of empty drums (before returning to store) is also part of their scope. All the drums should always be properly stacked in unit area. Gross wt. of each filled drum: 200 to 250 kg.

ITEM NO.100: TRANSPORT/ HANDLING OF LO/CHEM, DRUMS ETC.

OTY.: 600 UOM: NOS

Contractor shall carry out for the transportation / Handling of LO/, Chemical drums, hoses & other store items, sracps/ debris generated in unit area etc. as and when required as i. Transportation of LO/ Chemicals, drums from Central Store shall be done by in Hand Cart/ tractor trolly or as directed by EIC and then stacking properly in the designated area in unit. Shifting of used chemical/ LO drums from plant area to NRL Store (Designated area) shall be also be required. Before returning to store drum washing is to be done by the contractor. The scope of the job also includes loading & unloading on or from Truck / Trailer/hand trolly.

ITEM NO. 110: DEPLOYMENT OF EXTRA MANPOWER IN SHIFT DURING S/ U ETC.

Contractor shall engage extra manpower in the shift for assistance during start-up/shut down in the unit or any other days, as per instruction of EIC. Payment shall made to contractor against the manhours deployed, on submission of original of payment wage sheet.

Upkeepment of Unit area on emergency basis arising out of sudden spillage of oil, Tank sludge, etc to clean up area strictly as per direction of SIC / Unit IC or EIC by mobilizing required manpower and other resources immediately. Contractor shall deposit the employee as well as employer's contribution against PF, EDLI and Adm charges, for nos. of workers engaged, to statutory body, on monthly basis. He will submit the challan along with monthly wage sheet to EIC. Payment shall be made against the submission of the challan after verification by EIC.

ITEM NO. 210: Employer's contribution against ESI.

Contractor shall deposit the employee as well as employer's contribution against ESI, for nos. of workers engaged, to statutory body, on monthly basis. He will submit the challan along with monthly wage sheet to EIC. Payment shall be made against the submission of the challan after verification by EIC

ITEM NO. 220: Employer's contribution against WCI.

QTY: 12 UOM: AU

Contractor shall make an insurance policy for the workers engaged by him, valid for the contractual period one yr. He shall submit the copy of policy to EIC. He shall deposit the premium/s to the insurance company, as and when applicable as per terms of the policy. The employer's contribution against WCI (Workman Compensation Insurance) shall be paid against submission of for copy of the premium receipt and certified copy of insurance policy.

ITEM NO. 230: Supply of Safety shoes to the workers.

Contractor shall supply the safety shoes to all the workers engaged by him. Safety shoe shall be of size 5/6/7/8/9 with ankle protection. Colour -Black. Payment shall be made against the supply of shoe along with retailor's bill against purchase of shoes.

ITEM NO. 240: Supply of Safety Helmets to the workers engaged.

Contractor shall supply safety Helmets for contractor's workers. The Safety Helmet shall be made of HDPE, complete with 4 point stag on suspension (adjustable head band) Colour gree and non elasic nylon chin trap with buckle for adjustment. Helmet shall have IS- 2925-84 Marked. Colour- Blue. Payment shall be made against the supply along with retailor's bill against purchase of Helmet.

ITEM NO. 250: Supply of Boiler Suits to the workers engaged.

Contractor shall supply of boiler suits 2 pc in a year, for all his workers. ITEM NO. 260: Supply of Cotton Hand Gloves to the workers engaged.

OTY: 336 UOM: PAA

Contractor shall issue 2 pair of hand gloves every month to all his workers. The gloves should be of Cotton & PVC dotted for grip, size - 18". Payment to contractor shall made against supply and submission of bill/money receipt of purchases.

ITEM NO. 270: Payment against the balance leave.

QTY: 231 UOM: NOS

Contractor shall be make payment to workers against the balance leave at the end of the contractual period i.e. one yr. Payment to contractor shall be made with 12th/ final bill against the submission of Leave record and original of payment wage sheet.

ITEM NO. 280: Supply of tools and tackles.

QTY: 1 UOM: LS

Contractor shall purchase and supply various tools & tackles (required for execution of various jobs in the unit as mentioned in part-I), flower plants, sapling, etc. as per instruction of EIC. Payment shall be made against supply and submission of bill/money receipt.

2. CONTRACTUAL PERIOD:

The contractual period of completion for this job, as per the provisions of the contract shall be 12 (twelve) months to be reckoned from the date of site hand over by respective Engineer-in-charge (EIC).

The contract may be extended for another 12 (twelve) months based on your performance during the contract period and certification by EIC. The nos of items and its qty for the next yr will remain same. The rate of various SOR item (part-I) shall be increased based on the increase in labour wages only. Contractor should accept the revised rate of SOR items for part-I & part-II, as given by EIC, for the extended period.

- 3. PRE QUALIFICATION CRITERIA: Experience In Upkeepment nature of jobs in refinery / Hydrocarbon handling area with safety awareness.
- 4. SPECIAL CONDITIONS OF CONTRACT:
- 4.1 Contractor shall submit their offer for all SOR items of Part-I of the scope of work / supply(i.e. item no. 10-120) only.
- 4.2 Contractor shall quote unit rate for the PPE items mentioned against the item no. 230, 240, 250, 260.
- 4.3 Contractor shall not quote for item no. 200, 210, 220 &270. It shall paid per per std rate as applicable.
- 4.4 Payment against SOR items (part-I) shall be made, for the qty certified by EIC. Payment against items of part-II shall be made against the conditions mentioned above.
- 4.5 Contractor shall submit the required amount (employee as well as employer's contribution) against PF, ESI,WCI etc as per applicable rated to concern authority. Payment against employer's contribution shall be made to contractor on actual basis, on submission of proof like chalan etc. as mentioned above.
- 4.6 Contractor shall deposit the PF/ESI(employee as well as employer's contribution) to concern authority against each worker engaged by him, on monthly basis. Contractor shall submit the copy of chalan along with the monthly RA bill.
- 4.7 Contractor shall maintain one register in the format given by EIC for deposition of PF, ESI etc for each worker and the register should be submitted along with the chalan, every month to EIC.

- 4.8 Contractor shall submit annual return along with PF, ESI etc. deposits to the concerned authority by 31st March. He has to submit the proof of submission of the Annual return to the EIC or his representative. No bill will be processed till the submission of the Annual return, from April onwards.
- 4.9 Contractor has to mobilize/deploy adequate resources manpower, materials, tools & tackles etc to carry out the various jobs as per the scope of work, as and when required.
- 4.10 The worker engaged should have valid gate pass against the against the awarded Work Order no. only.
- 4.11 Leave records to be maintained by the contractor against each worker. Contractor has to submit the leave records of the worker to the engineer in charge or his representative every month. Payment against Item no. 280 i.e. balance leave of worker shall be made with 12th/ final RA bill.

- 4.13 Abook to be maintained by the supervisor to keep records of the certification. It will be a part of duty of the supervisor to get the certification of the day to day jobs by field Personal as well as shift officers.
- 4.14 Contractor shall mobilize the additional manpower against the item No. 110& 120, within 24hrs, in case EIC inform to execute a job on priority/ emergency basis.
- 4.15 All the jobs are to be executed as per the instruction of EIC. He shall deduct the bill, if the job is not executed to the satisfaction of EIC' shift officer.
- 4.16 All working persons must use the PPE/ safety gadgets as per the job requirement. Without PPE no person will be allowed to work inside the refinery premises. Contractor must ensure that required PPE has been provided to for all his workmen, on daily basis, as required.
- 4.17 The contractor will have to abide by all safety and statutory regulation prevailing inside the refinery premises.
