- 3) Waivers from next of kin
- 4) Certified copy of Death Certificate
- 5) \$72.00 Filing Fee (If the will and codicil(s) are 5 pages or less and you have <u>all</u> waivers)

(We accept cash, check, money order, mastercard or visa.)

✓ Filing fee includes \$45.00 for <u>Court Cost</u> and \$27.00 for <u>Notice to Creditors</u>.

✓ If the Will and Codicil(s) are more than five (5) pages, please add an additional \$1.50 for each page of the Will after the five.

- ✓ In addition, if notice has to be given or a Guardian Ad Litem appointed, there will be <u>additional costs</u> that are assessed the day of the hearing to probate the Will.
- **NOTE:** There may be other documents or additional costs that are required depending on the situation, such as renunciation, bond, etc.

These forms are not always appropriate for <u>ALL</u> Probate of Wills and Codicil(s).
