入學要求

(i) 短期課程

凡年滿16歲並持有有效之香港永久性居民身份證、或持有由香港特區政府入境事務處所簽發的學生簽證或有效證件來港就讀的人士,不論學歷(除註明外),皆可報名修讀。

(ii) 遙距課程及網上自學課程

凡年滿16歲人士,不論學歷(除註明外),皆可報名修讀。

報名程序

填妥的報名表格必須連同所有有關資料副本(如有註明)及支票/銀行本票/銀行收據(如適用),郵寄(請在信封面註明「報名表格」)或於辦公時間內交回報名中心或總辦事處。申請將於報名表格、所有有關資料副本(如有註明)及學費完整收妥後才獲處理。本院一般於開課前發出收據及上課證予申請人,若於開課前四天或截止日期後報名的申請人於上課時仍未收據及上課證,請致電報名組2209-0290或聯絡個別學部查詢。若要求額外的收據或上課證,每張將收取行政費用HK\$50。除特別通知外,申請人須依照本院網頁或課程手冊上之指定時間、日期和地點上課。如網上版本與課程手冊版本有任何不符之處,應以網上版本為準。本院將不會發出取錄通知書給「短期課程」的申請人。

繳費辦法

(i) 支票/銀行本票

如用支票/銀行本票,請以「香港中文大學」名義抬頭,並加橫線,連同報名表格一併遞交。本院恕不接受期票。如報讀超過一個課程,請分別填寫報名表格及開列支票/銀行本票,並在支票/銀行本票背面寫上申請人姓名、香港身份證號碼及課程編號。如欲報讀之課程已額滿或取消,本院將退回支票/銀行本票。為免因銀行結算而導致進一步延誤,如開課日期將至(例如少於三個工作天),本院不建議申請人使用支票繳交費用。如支票不能分現,有關申請人須於收到本院職員通知當日起的三個工作天內繳付學費。逾期辦理將不獲保留學額或被取消上課資格。

(ii) 現金

申請人可於任何一間恒生銀行(不包括港鐵站內之恒生銀行)以現金 繳費,報名中心恕不接受任何現金繳費。本院之銀行入數紙可於報名 中心、總辦事處或恒生銀行索取。本院銀行入數紙副本 (SCS Copy) 須於繳付學費後連同報名表格一併交回或郵寄至報名中心或總辦事處。

(iii) 易辦事

本院報名中心設有「易辦事」的繳費服務。

(iv) Visa / 萬事達卡

本院報名中心設有Visa/萬事達卡的繳費服務。請於報名表格上清楚填寫信用卡持有人姓名、信用卡編號、發卡銀行及有效日期。如信用卡繳費未能入賬,申請人須於收到本院職員通知當日起的三個工作天內繳付學費。逾期辦理將不獲保留學額或被取消上課資格。

(v) 香港中文大學專業進修學院信用卡

持卡人凡於本院修讀任何課程,而該課程*的學費達HK\$2,000或以上,可享六個月或十二個月免息分期付款優惠。如免息分期金額達HK\$5,000或以上,申請人需繳付手續費以享免息分期付款優惠。

*若課程由超過一個單元組成,則個別單元的學費必須達HK\$2,000或以 上,申請人才可享用免息分期付款優惠。

退款

除非因課程額滿或取消,否則已繳之學費恕不退還。退款將會轉入申請人之 銀行戶口。如申請人在遞交「課程額滿/取消通知書」後四至五星期仍未收 到退款,請致電 2209-0290 與報名組聯絡。

課程轉修

於課程額滿或取消的情况下,申請人可獲安排轉修另一課程。在其他任何情况下,申請人必須得到本院同意及以支票/銀行本票或信用卡繳交行政費 HK\$100才可轉讀另一課程。此項申請須於已報讀課程之開課日期前一星期提出,逾期恕不受理。此外,學員已繳之學費及其學額不得轉讓他人。

課程更改

如報名人數不足,本院有權取消該課程,並於有需要時更改任何原定課程之 導師、上課時間、地點及內容。

需要特殊學習安排之申請人

如申請人需要特殊學習安排,請於開課前與報名組或個別學部聯絡。申請人所提供的資料,本院只用作進一步了解學生的需要及處理有關事宜,以提供 適當的安排及照顧。

進修積分計劃

為鼓勵持續進修,香港中文大學專業進修學院推出「進修積分計劃」(以下簡稱「計劃」)。在「計劃」下,報讀本院課程的學員均可賺取積分,有關積分將可回贈於報讀下一個課程,以繳付部分學費。

Admission Requirements

- (i) General Courses
- Anyone aged 16 or above with a valid Hong Kong Permanent Identity Card/Hong Kong Student Visa is eligible for enrolment. Except otherwise specified, no formal education qualification is required.
- (ii) Distance Learning and e-Learning Courses
 - Anyone aged 16 or above is eligible for enrolment. Except otherwise specified, no formal education qualification is required.

Enrolment Procedures

Please complete the enrolment form and send copies of supporting documents (if specified) and cheque/bank draft/bank receipt (if any) to one of the Enrolment Centres or Head Office in person or by mail (please mark "Enrolment Form" on the envelope). Applications will be processed only upon receipt of the completed enrolment form, copies of supporting documents (if specified) and payment. Receipt and Attendance Permit will normally be issued before course commencement. The School will not be responsible for any loss of Receipt and Attendance Permit dispatched by regular mail. If you do not receive the above items four calendar days prior to course commencement date (or during a class meeting as early as possible for late enrolment), please check with the Enrolment Team at Tei: 2209-0290 or the respective Academic Division. There is an administrative fee of HK\$50 on every request for an additional copy of the Receipt or Attendance Permit. Unless otherwise notified, applicants are expected to be present for class at the time and place indicated in School website or the Prospectus. In the event of any inconsistency between the online version and the Prospectus version, the online version shall prevail. For General Courses, no separate letter of acceptance will be issued.

Payment Methods

- (i) Cheque/Bank Draft
 - Crossed cheque/bank draft should be made payable to "The Chinese University of Hong Kong" and returned together with your enrolment form. Post-dated cheque will not be accepted. Applicants who enrol for more than one course should issue a separate cheque/bank draft for each course. Please write the applicant's name, HKID card no. and course code on the back of each cheque/bank draft. Cheque/bank draft will be returned if courses enrolled are full or cancelled. If you are making payment very close to course commencement (say less than three working days), you are advised against using cheque in view of further delay arising from bank clearance. If the cheque is rejected by bank, the applicant concerned will be required to pay the tuition fee within three working days upon receipt of notification from the School. Failure to do so will result in cancellation of enrolment or suspension from taking subsequent classes.
- (ii) Cash

Cash payment is not accepted at Enrolment Centres and can be made via Hang Seng Bank (excluding Hang Seng Bank at MTR Station). CUSCS bank slip is obtainable from Enrolment Centres, Head Office or Hang Seng Bank. "SCS copy" of the bank slip should be returned together with enrolment form to Enrolment Centres or Head Office in person or by mail.

- (iii) EPS
- EPS payment can be made at Enrolment Centres.
- (iv) Visa/Master Card

Visa/Master Card payment can be made at Enrolment Centres. Card holder's name, card number, card issuing bank and expiry date should be completed clearly in enrolment form. If the card payment is rejected by bank, the applicant concerned will be required to pay the tuition fee within three working days upon receipt of notification from the School. Failure to do so will result in cancellation of enrolment or suspension from taking subsequent classes.

- (v) School of Continuing and Professional Studies CUHK Credit Card
 - Cardholders can enjoy a 6-month or 12-month interest-free instalment plan privilege on tuition fees upon enrolment of any of our courses* at a cost of HK\$2,000 or above. For instalment amount of HK\$5,000 or above, applicants are required to pay a handling fee for the interest-free instalment plan.
 - * If the programme consists of more than one module, applicants may enjoy the interest-free instalment plan only when the tuition fee of each individual module costs HK\$2,000 or above.

Refund

Fees paid are not refundable unless the enrolled course is full or cancelled. The School will transfer the refund to the bank account of the applicant concerned. If you do not get the refund four to five weeks after returning the "Notification of Course Over-subscription/Cancellation", please check with the Enrolment Team at Tel: 2209-0290.

Course Transfer

Transfer to another course could be arranged if the enrolled course is full or cancelled. In any other event, transfer to another course can only be made subject to the approval of the School and with an administrative fee of HK\$100 settled by cheque, bank draft or credit card. The application must be made no less than one week before commencement date of the enrolled course. Late application will not be considered. Fees paid and the related studentship cannot be transferred from one person to another.

Course Changes

CUSCS reserves the right to cancel a course if enrolment is insufficient and make alterations regarding instructors, class schedules, class locations and the course content if necessary.

Applicants with Special Learning Needs

Applicants requiring special assistance are advised to contact the Enrolment Team or the respective Academic Division before course commencement. The information you provided is used by the School only for the purposes of better understanding your needs and processing any suitable arrangement and care if necessary.

CUSCS Cash Unit Scheme (CATS)

To encourage students pursuing continuing studies, the School has introduced an incentive scheme - "CUSCS Cash Unit Scheme (CATS)". Under this scheme, students enrolled on our courses will be granted cash units which they can use to partially pay their tuition fees of future enrolments. Please refer to CUSCS prospectus and website or contact our staff for details.

- CATS is designed to encourage students to take part-time general courses and award-bearing programmes solely offered by the School.
 The cash units cannot be rebated in the enrolment of full-time programmes, corporate training
- The cash units cannot be rebated in the enrolment of full-time programmes, corporate training programmes or programmes jointly offered by the School in collaboration with local organisations, overseas and Mainland universities.
- As advised by the Labour and Welfare Bureau, the Scheme (CATS) is regarded as offering a discount and as such is not permitted under the Continuing Education Fund rules. With effect from 1 August 2010, cash units cannot be used in all CEF reimbursable courses (including the whole programme or individual modules of a programme listed as CEF reimbursable courses).
