#### **Background**

Although frequently considered as a response to the state of the target stock patterns of fishing activity are driven primarily by the market price of the products they catch. Fishing is, after all, an economic activity, so patterns of fishing have an awful lot to do with the price of fish! Importantly the economics of fisheries not only influences the decisions of legal operators but also the decision of those that operate outside of fisheries management measures and deliver products to the same markets.

Gathering data on the price of fisheries products can involve simply going to the local fish market. However, for Antarctic fisheries that sell into a global market, the gathering of such data presents different challenges. CCAMLR, the international body that manages fishing in the Antarctic, has in place a catch-documentation scheme that tracks products from the vessel to the consumer. Along this supply chain the value of the product will change as it is processed and packaged to suit a particular market. The price will also vary depending on the product quality, the specific fishery (and any eco-labelling/third party certifications for that fishery) and the market place for which it is intended.

Using a combination of internet searching and stakeholder consultation the project will construct a value-chain for "Chilean Seabass' caught in CCAMLR fisheries and produce a system for assessing trends over time in the 'price of fish'. This will contribute to a greater understanding of the factors influencing participation (both legal and illegal) in toothfish fisheries in the Antarctic and how this might change in the future.

## **Project Outline, Objectives and Methods**

The Internship will be hosted in the CCAMLR Secretariat in Hobart and will be jointly supervised by the Science Section and the Fisheries Monitoring and Compliance Section.

This will involve a combination of internet-based market research and stakeholder consultation.

The outcomes of the project will include a database of prices sources for toothfish products that can be updated in the future and a paper to be presented at CCAMLR meeting (either as a stand-alone paper or as part of a broader analysis).

In addition to the research project on the economics of toothfish the Intern will also be engaged in routine tasks undertaken by the Secretariat as they arise. This will provide the Intern with an understanding of the nature and variety of the work of the Secretariat of a multi-lateral organisation such as CCAMLR.
