### **ASSOCIATE - MEMBER :**

An individual engaged or having an interest in land surveying. This may include employees of another surveyor or Firm-Member or someone in an associated profession such as engineering, architecture, cartography, forestry, geology, law or photogrammetry. -----**\$80.00**

### **FIRM - MEMBER :**

A sole proprietorship, partnership or corporation in the business of providing professional land surveying services in the State of Connecticut and having a minimum of one Surveyor-Member.

A Surveyor-Member in good standing for an uninterrupted period of ten (10) years prior to retirement from the active practice of land surveying and having attained "retired" status as defined by the Social Security System. -----**\$30.00**

A full-time student studying or having an interest in surveying. -----**\$15.00**

### **SURVEYOR - MEMBER :**

An individual licensed to provide professional land surveying services in the state of Connecticut.
