San Diego DJ and Karaoke agrees to provide the listed musical equipment as rental under the following conditions: each 24 hours. All property is owned by San Diego DJ and Karaoke and may not be sold, lent, mortgaged, or encumbered in any way. Any digitally stored medium including CD's and computer files are licensed to San Diego DJ and Karaoke and may not be copied, deleted, moved or transferred by anyone. Any item damaged, lost, stolen or not returned in as new condition upon expiration of the 24 hour rental agreement shall be billed to the renter for the full replacement value. Renter agrees to be financially responsible for all loss, damage, theft or acts of God and agrees to reimburse San Diego DJ and Karaoke for the full replacement value of each individual item and authorizes San Diego DJ and Karaoke to charge the credit card given at time of deposit for any item damaged or not returned, in accordance with the cost schedule listed below. Renter assumes full responsibility for storage, security, use and protection of equipment until returned. Failure to return equipment within 24 hours of delivery will be charged for an additional 24 hours. Failure to return equipment after 48 hours will be charged the full replacement value of all equipment. San Diego DJ and Karaoke will provide free delivery and pick-up in the metro San Diego area, to a single ground level location no more than 100 feet from delivery vehicle. ANY stairs or steps beyond a normal 3 step porch will result in a delivery charge of \$25 which you agree may be charged to your credit card. Payments are non refundable. Renter MUST be present for all deliveries and pick-ups. Equipment will not be delivered to anyone but Renter.
