The policy design guarantees coverage to active members that apply for the benefit at the first time they are eligible. Members who decline this *one time option* and want coverage at a later time must wait until the next enrollment period which is normally the month of September. A completed health questionnaire will then be required and the member will either be accepted or declined for coverage by *The Hartford*.

The death benefit for all members is fifty per cent of the normal amount during their first year of coverage. Benefit levels *and* premiums reduce to 50 % at age 65 and then to 10% at age 70. This policy design was arrived at in order to provide the availability of guaranteed coverage for all active members at competitive premiums without regard to health status.

STATE NOTICE
