Transportation will be provided to resident students (k-8) who are under the care of a child care provider at a location other than the student's residence before and/or after the regular school day(excluding day care centers). In order to qualify, the following requirements must be met:

A. Both the child care provider and and the child's residence have to qualify for transportation. District qualifications for transportation include: Kindergarten through sixth-grade students who live one mile from school are eligible for transportation. Seventh- and eighth-grade students who live two miles from school are eligible for transportation. (seat availability option is offered)

B. The provision of such transportation for such students must not cause the school district to incur any additional costs or require the establishment of any new bus routes. Such transportation shall be provided only if there is sufficient space for such pupils on the appropriate buses after space has been made available for all other students who have qualified transportation service.

C. This transportation service, as requested by the parent/guardian, will be provided to or from only one stop location (exclusive of home stop) for no less than two days per week.

D. This form must be filed with the Transportation Department a minimum of five working days before the required service. For service to start within the first three weeks of school, this form must be received by the Transportation Department prior to August 1.

E. Exceptions may be made for unanticipated special needs such as a death in the family or hospitalization of parent or child care provider, but not for vacations or changes in parent/guardian work schedules. This emergency change in transportation service will be for a continuous period of no less than three consecutive school days.
