THROUGH THE CAMPAIGN, MLI RAISES PRIVATE FUNDING TO PROVIDE HIGHLY TRAINED MDDS TO "SNIFF OUT" LANDMINES AND TO SAVE AND IMPROVE LIVES IN SEVERELY CONTAMINATED, WAR-TORN COUNTRIES.
