In the event the cost of any of the above specified building material or materials, exclusive of any other price changes, that would cause the total contract price/sales price to increase by more than _______%, the Builder/Seller shall, before making any additional purchases of specified material or materials, provide to the Owner/Buyer a written statement expressing the percentage increase of the contract price/sales price, the building material or materials in question, and the dollar amount of the price increase to be incurred. The Owner/Buyer may then, at its option, either (i) approve such price increase; or (ii) terminate the Agreement by providing to Buyer/Seller, within ten (10) business days after receipt of such written statement, both written notice of termination, and payment to the Builder/Seller for all costs expended in performance of the Agreement to the date of termination, plus payment of a prorated percentage of the Builder/Seller's profits based on the percent of completion. Should both notice of termination and full payment not be forthcoming within ten (10) business days, as provided herein, the Builder/Seller shall have the option to terminate the Agreement, or to proceed with the Agreement and purchase the specified building materials at the increased price. If termination is elected, the Builder/Seller shall provide to the Owner/Buyer a written notice of termination, and the Owner/Buyer shall be required to pay the Builder/Seller for all his costs expended in performance of the Agreement to the date of termination, plus payment of a prorated percentage of the Builder/Seller's profits based on the percent of completion. If the Builder/Seller elects to proceed on the Agreement, it may then purchase the specified material or materials at the increased price, and the Owner/Buyer shall be required to pay the increased cost incurred.

In the event of any inconsistency between the provisions of the Agreement and the Addendum, this Addendum shall control.
