In order for the Manatee County Tax Collector's office to process your paperwork, you must provide proof that you reside in Manatee County either on a full-time basis or a part-time basis. (If you cannot provide proof of Manatee County residency, you cannot process your paperwork by mail in Manatee County.) Please submit a copy of one of the following items indicating a Manatee County address:

- > Florida Driver license (must have a Manatee County address)
- Paid receipt for utility, telephone service, paid contract or turn-on order for utility service
- Proof of homestead exemption
- > Rental or lease contract agreement
- > Current year motor vehicle, mobile home or vessel certificate of registration
- > Copy of insurance policy for motor vehicle, mobile home or vessel
- Other documentary evidence that provides independent proof of a Manatee County address

In order to obtain a Florida title, please send the following:

1. IDENTIFICATION REQUIREMENTS:

<u>All individual(s) must submit</u> a copy of one of the following with the application for title:

- A driver license or ID card with photo issued by any US state or territory (Florida driver license must indicate a Manatee County address).
- A Canadian driver license or ID card
- A US or out-of-country passport
- If transaction is being completed by <u>Power of Attorney</u> a copy of the driver license for both the applicant and the person appointed power of attorney is required.

2. APPLICATION FOR CERTIFICATE OF TITLE:

You can fill in and print the <u>Application for Certificate of Title</u> here.

Complete sections 1, thru 6. If company owned, FEID number MUST be included.

- It is mandatory that a Florida address be provided in section 1 of the Application for Certificate of Title under the "Owner's or Lessee's <u>Physical</u> <u>Street Address in Florida</u> (Mandatory)" section.
- If out-of-state title, section 8 MUST be completed but <u>only</u> by a law enforcement officer, Military police - Provost Marshal, a commissioned or warrant officer in active military service, or a Legalman (non-commissioned officer in the rank of E-7 or higher) or a Florida certified notary. Owners may not verify their own VIN number.

Note: An out-of-state motor vehicle dealer may verify a VIN number on their letterhead signing and attesting to the fact that they have physically verified the VIN to be correct with a full description of the vehicle year, make and VIN; the letter must state that the dealer physically verified the VIN number. A <u>Dealer</u> <u>VIN Verification for Out-of-State Dealers</u> template may be copied onto the dealer's letterhead and completed. All signatures must be original. (An out-of state motor vehicle dealer may <u>not</u> complete section 8 of form 82040.)

All applicants MUST sign section 12. (If signing as an agent of a business, the agent's position with the business must be noted.)

3. ONE OF THE FOLLOWING MUST BE SUBMITTED TO SHOW PROOF OF OWNERSHIP: (<u>CAUTION: COPIES CANNOT BE ACCEPTED</u>)

- <u>NEW CAR</u>: Manufacturer's Statement of Origin Note: Odometer statement must be completed on the back of the MSO or an original odometer statement completed by DEALER & PURCHASER must be submitted.
- <u>USED CARS</u>: Florida Title or Out-of-State Certificate of Title (Registered in another state). Note: Used vehicles 10 years or newer require the odometer and the date read to be disclosed per Federal Odometer Laws.

*The title must be signed over on the purchaser and seller lines and the odometer disclosure statement & applicable dates must be completed when:

- Ownership is changing
- Adding/removing a name
- Transferring to/from a trust
- Name change

4. BILL OF SALE OR COPY OF DEALER INVOICE:

Not required on vehicles titled or registered in the owner's name for 6 months or longer. If owned less than 6 months you must supply our office with proof that sales tax was paid. If sales tax collected was less than our state sales tax, the difference will be due.

Note: An exemption may apply, if a member of the United States military, who is a permanent Florida resident, is stationed outside Florida, purchases a vehicle outside of Florida (*but in the United States*) and is applying for a Florida title and registration. The transfer of title and registration of the vehicle is not subject to Florida sales and use tax if the vehicle will not be brought into Florida within 6 months from the date of purchase. A copy of the military member's military orders indicating military member is stationed outside of Florida (not to expire for at least six months from the date of application for Florida title) and an affidavit stating the vehicle will not be brought into Florida within six months. Please complete the <u>Military Affidavit</u> if this applies to you. A dealer invoice/bill of sale must also be submitted.

5. CURRENT REGISTRATION:

If you are transferring a Florida license plate that is registered to the same owner(s) of this vehicle, a copy of the current registration must be submitted OR list the plate number in section 2 of the Application for Certificate of Title.

6. MILITARY ORDERS:

A copy of your military orders must be submitted.

7. INITIAL REGISTRATION FEE EXEMPTION AFFIDAVIT:

The <u>Initial Registration Fee Exemption Affidavit</u> form is to exempt the Initial Registration Fee to qualified military members. The top section must be completed with the vehicle information. Military members must review page 2 of this application and select a qualifying exemption and enter that exemption number on page 1. The military member must sign, print and date at bottom of form.

8. PROOF OF INSURANCE:

<u>Florida residents</u> (including dependent spouses) outside of Florida due to military assignment must provide the following:

- 1. An out-of-state mailing address (which will be shown on the registration)
- 2. A Florida address of residence (which will be shown in the DMV database)
- 3. <u>One</u> of the following, which proves current military assignment out-ofstate:
 - a. A copy of the military orders, OR
 - b. <u>Military Affidavit</u> completed by the military member's commanding officer that confirms the member's military orders and the date of assignment
- 4. An affidavit stating the motor vehicle is being maintained in the member's state of military assignment and will not be driven in Florida, except in a transient visitor status. This can be placed on the same Military Affidavit mentioned above.
- 5. Proof of insurance in the form of <u>one</u> of the following:
 - a. Florida insurance
 - b. Or, the customer can submit out-of-state insurance provided it is on the insurance company's letterhead stationery and it contains <u>all</u> of the following: (a faxed letter on letterhead stationery is permissible)
 - A statement that the military ember or dependent spouse is currently insured in the state where s/he is actively stationed
 - Name of insured
 - Effective date of policy
 - Insurance company name
 - Policy number
 - Vehicle(s) covered

<u>Non-resident</u> military personnel stationed in Florida, who register their vehicles in Florida, **must have Florida insurance.** Complete the <u>Florida Insurance</u> <u>Affidavit</u>. Insurance in Florida by an out-of-state insurer is not sufficient; insurance must be furnished from a company licensed in Florida.

Please note: This affidavit may only be completed if you have a current <u>Florida</u> insurance policy.

Please Note: For military personnel claiming a Florida Insurance exemption, an out of state address for mailing purposes is required in section 1 of the Application for Certificate of Title under the "Owner's <u>Mailing</u> Address (Mandatory)" section.

9. CHECK or money order in US funds made payable to Ken Burton, Jr. Tax Collector. <u>Your check is welcome provided it includes:</u> Full Name, Street Address, Home Telephone # with area code, Driver License # and State of Issuance. Starter checks are not acceptable. If your check is returned, it may be represented electronically. By submitting your payment by check, you are authorizing service charges and processing fees, as permitted by F.S. 832, to be debited from the same account by paper draft or electronically, at the option of the Tax Collector. Amount will be line 7 on page 6.

Note: Please allow 10-14 business days for processing and mail time. If you would like expedited mail services, a prepaid overnight envelope must be supplied with your transaction. *Fast titles <u>cannot</u> be issued by mail.

COMPUTATION OF AMOUNT DUE FOR APPLICATION FOR A FLORIDA TITLE

The 12 month registration period for automobiles and trucks weighing less than 5,000 pounds begins the first day of the owner's birth month. (Exception: Company owned vehicles use the month of June). The registration fee is determined by the first owner's birthday and empty weight of the vehicle.

To determine the number of months required, start with the month the vehicle is being registered in Florida and count through to the owner's birth month.
