Quick relief from e-mail overload

If you are feeling overburdened and stressed at work, your online habits may be partly to blame. Poor e-mail management often is a sign – or the cause – of other time management woes. A top culprit: mismanaging incoming messages.

Marsha Egan, president of The Egan Group, a success – coaching firm, offers a self-management program that teaches you how to eliminate time-draining e-mail habits and boost your productivity. First, Egan says, you need to altar your perception of e-mail: stop viewing the act of checking e-mail as a task in itself: come to see e-mail as merely a task delivery system. Then adopt these habits:

Empty your inbox every time you check it.

- Live by the two-minute rule. If you can handle any incoming message in two minutes or less, do so immediately. That could mean replying to, forwarding or simply deleting a message.
- Use a filing system. Create action folders and use them temporarily to file e-mail messages that will take longer than two minutes to respond to.
- Treat those messages as items on your daily to-do list.
- Control incoming messages instead of letting them control you.
- Change your "send and receive" e-mail function from "Automatic" to "Every two hours".

NECA Co-Sponsored Retention Reform

The NECA co-sponsored legislation to cap the amount of retention in which public agencies can withhold on public works projects at 5% continues to move through the legislative process. The measure, SB619 (Migden), has yet to receive a no vote as the state legislators understand the tight profit margins contractors operate on and are sympathetic to releasing cash flow on work that has been performed and approved. After clearing both the Senate Policy and Senate Appropriations committees, the bill will now go to the Senate floor for vote.

New Focus on Liability Insurance Reform

This measure closed a potential loop-hole in our 2005 legislative enactment prohibiting "type-1" indemnification agreements in residential construction contracts. The measure clarifies that all builder are within the rule applicable to every other builder.

NOTICE TO ALL RETIREES RECEIVING A NORMAL OR EARLY RETIREMENT PENSION BENEFIT CONCERNING A TEMPORARY RETURN TO WORK AMENDMENT TO THE PLAN OF BENEFITS FOR THE NEBF

The Trustees of the National Electrical Benefit Fund (NEBF) and the National Employees Benefit Board have approved a temporary Return to Work Amendment to the Plan of Benefits for the NEBF that **permits certain eligible retirees to return to covered and contributory employment for a period of time without a loss of pension benefits from the NEBF.** Please read the following notice carefully, as this amendment does not apply to all retirees or to all electrical employment.

As you are aware, the rules of the Plan generally provide for a suspension of benefits for a retiree who returns to employment in the electrical industry for forty (40) or more hours per month. This temporary Return to Work Amendment changes the suspension rules for certain eligible retirees. Following are the features of the amendment:

- 1. The temporary amendment is effective from **September 1, 2007 through December 31, 2007.**
- 2. All normal and early retirees with a pension effective date of August 2007 or earlier will be permitted to return to covered and contributory employment only and will be permitted to work for up to 600 hours during the above period without a loss of NEBF benefits (your receipt of benefits from other funds will depend on rules of those funds).
- 3. Once an individual has worked for 600 hours in covered and contributory employment during the term of the temporary amendment, the individual will not longer be able to take advantage of this amendment and the normal rules (permitting work in the electrical industry for less than forty (40) hours per month without a suspension of benefits) will apply.
- 4. Disability pensioners are not eligible (the existing rules applicable to disabled pensioners remain in effect).
- 5. Only retirees who return to NEBF covered and contributory employment will be able to take advantage of this amendment this amendment will not apply to persons who work for covered employers where no NEBF contributions are required or to persons who work for non-covered employers in the electrical industry.
