

Participation Agreement

As an employee of Sprint Nextel, I understand that I am eligible to participate in the Direct Dining Payroll Deduct program. My participation in Direct Dining permits me to purchase meals and/or products sold by ARAMARK, Inc. and pay for them by payroll deduction.

By signing this document, I agree to the following conditions:

1. Direct Dining privileges may be revoked by ARAMARK at any time with or without notice to me.
2. I will report the loss of my Sprint Nextel employee identification card and/or misuse of my Direct Dining account as soon as I learn of any lose or misuse, but no later than one (1) business day after learning of such loss and/or misuse.
3. I authorize my employer to withhold from my regular check the amount claimed by ARAMARK as due ARAMARK for purchases made with my Direct Dining account and to pay such amount to ARAMARK. I understand that each use of my Direct Dining account acts as my acceptance and approval of the amount of such purchase. If I choose to stop using payroll deduction (Direct Dining) as a payment option, I understand that I must notify ARAMARK in writing and am responsible for payment of all purchases made with my Direct Dining account prior to cancellation of my Direct Dining account by ARAMARK.
4. ARAMARK reserves the right to change or cancel the Direct Dining program, at any time, without prior notice.
5. I will discuss any and all questions regarding purchases using my Direct Dining card with the ARAMARK Direct Dining Administrator. The Sprint Nextel payroll department is not responsible for the Direct Dining program.
